Dear Speaker Simina:

I am pleased to transmit the following Congressional Act, which I have approved to become Public Law No. 19-45:

Congressional Act No. 19-47, entitled: "AN ACT TO APPROPRIATE A SUPPLEMENTAL BUDGET IN THE AMOUNT OF \$112,500 FROM THE GENERAL FUND OF THE FEDERATED STATES OF MICRONESIA FOR THE FISCAL YEAR ENDING SEPTEMBER 30, 2016, BY AMENDING SECTIONS 1, 8, AND 12 OF PUBLIC LAW NO. 19-32, TO PROVIDE FOR AN ADDITIONAL CONTRIBUTION TO THE INTER-PARLIAMENTARY UNION, TO PAY OVERDUE MEMBERSHIP FEES, TO DESIGNATE THE ALLOTTEE AND CHANGE THE ALLOTTEE OF FUNDS PREVIOUSLY APPROPRIATED THEREIN, AND FOR OTHER PURPOSES."

As indicated on its title, the Act appropriates \$112,500 as contribution to the Inter-Parliamentary Union including the payment of overdue membership fees. I find no issue with this supplemental budget; therefore, I signed into law.

However, the Act also deletes the lapse date of funds – subsection 12(3) in the budget. This could be a typographical error, but I urge Congress to reinstate this subsection at the earliest opportunity in order to avoid any doubt on the lapse date of funds in the FY16 Budget.

AN ACT

To appropriate a supplemental budget in the amount of \$112,500 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2016, by amending sections 1, 8, and 12 of Public Law No. 19-32, to provide for an additional contribution to the Inter-Parliamentary Union, to pay overdue membership fees, to designate the allottee and change the allottee of funds previously appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 19-32, is hereby
2 amended to read as follows:

3 "Section 1. Purpose. The purpose of this act is as
4 follows: To appropriate the sum of \$75,542,323 from
5 the General Fund of the Federated States of
6 Micronesia for the fiscal year ending September 30,
7 2016, for the purpose of funding the operations of
8 all branches of the National Government of the
9 Federated States of Micronesia, its agencies, various
10 programs, grants, subsidies and contributions and
11 Capital and Human Resources Development. The
12 National Government's share of the Amended Compact
13 funds has been reduced to zero except that the
14 National Government will retain 10 percent of the
15 Supplemental Education Grant funds as is reflected in
16 the budget for the Department of Education. The sum
17 appropriated herein shall be apportioned as follows:"

1 Section 2. Section 8 of Public Law No. 19-32 is hereby
 2 amended to read as follows:

3 "Section 8. Grants, Subsidies and Contributions.
 4 The sum of \$10,981,139, or so much thereof as may be
 5 necessary, is hereby appropriated from the General
 6 Fund of the Federated States of Micronesia for the
 7 fiscal year ending September 30, 2016 for the
 8 following grants, subsidies and contributions during
 9 the fiscal year 2016. The sum appropriated by this
 10 section shall be apportioned as follows:

23 Section 3. Section 12 of Public Law No. 19-32 is hereby
 24 amended to read as follows:

25 "Section 12. Allotment and management of funds

1 and lapse dates.

2 (1) General provisions.

3 (a) All funds appropriated by this act shall be
4 allotted, managed, administered and accounted for in
5 accordance with applicable law, including, but not
6 limited to, the Financial Management Act of 1979.

7 (b) The allottees shall be responsible for
8 ensuring that these funds, or so much thereof as may be
9 necessary, are used solely for the purposes specified in
10 this act, and that no obligations are incurred in excess
11 of the sums appropriated.

12 (2) Allottees. The allottees of the funds
13 appropriated by this act are as follows:

14 (a) Section 2 - the allottee of these funds
15 shall be the President of the Federated States of
16 Micronesia;

17 (b) Section 3 - the allottee of these funds
18 shall be the Speaker of the Congress of the Federated
19 States of Micronesia;

20 (c) Section 4 - the allottee of these funds
21 shall be the Chief Justice of the Supreme Court of the
22 Federated States of Micronesia;

23 (d) Section 5 - the allottee of these funds
24 shall be the Public Auditor of the Federated States of
25 Micronesia;

1 (e) Sections 6 through 9 - the allottee of
2 these funds shall be the President of the Federated
3 States of Micronesia; PROVIDED HOWEVER, that for the
4 following subsections of sections 8 through 9 of this
5 act:

6 (i) Section 8(6)(g) - the allottee shall be
7 the President of the College of Micronesia - FSM; and

8 (ii) Section 8(6)(h) through (i) - the
9 allottee of these funds shall be the Governor of the
10 State of Chuuk;

11 (iii) All subsections under Section 8(9) -
12 the allottee of these funds shall be the Speaker of the
13 Congress of the Federated States of Micronesia; and

14 (iv) Section 8(12)(a) through (d) - the
15 allottee of these funds shall be the Chief Justice of the
16 respective State Supreme Court;

17 (v) Section 8(12)(n) - the allottee of these
18 funds shall be the Speaker of Congress of the Federated
19 States of Micronesia.

20 (vi) Section 9(1)(a) through (c) - the
21 allottee of these funds shall be the President of the
22 College of Micronesia-FSM;

23 (vii) Section 9(12)(a)(ii) - the allottee of
24 these funds shall be Governor of Chuuk State; PROVIDED
25 THAT, the Governor shall submit the proposed uses of said

1 funds in accordance with priorities of Chuuk State to the
2 Chuuk State Legislature for its consideration and action.

3 (viii) Section 9(12)(b)-(d) - the allottee of
4 these funds shall be the Governor of the respective
5 states.

6 (ix) Section 9(12)(f) - the allottee of
7 these funds shall be the Chief Justice of the Kosrae
8 State Supreme Court.

9 (x) Section 9(12)(g) - the allottee of
10 these funds shall be the Chief Justice of the Chuuk State
11 Supreme Court.

12 (xi) Section 9(12)(h) - the allottee of
13 these funds shall be the Chief Justice of the Yap Supreme
14 Court.


15 (xii) Section 9(12)(i) - the allottee of
16 these funds shall be the Chairman of the Chuuk Delegation
17 to the FSM Congress.
