PUBLIC LAW No. 19-119

AN ACT

To further amend Public Law No. 19-54, as amended by Public Laws Nos. 19-62, 19-75, 19-79 and 19-99, by amending section 4 and 6 thereof, to change the use and allottee of funds previously appropriated therein, to fund public projects and social programs in the state of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 19-54, as amended by
2 Public Laws Nos. 19-62, 19-79 and 19-99, is hereby further amended
3 to read as follows:

4 "Section 4. Of the sum of \$4,800,000 appropriated by
5 this act, \$1,400,000 is apportioned for public
6 projects and social programs in the state of Pohnpei.

17 Section 2. Section 6 of Public Law No. 19-54, as amended by
 18 Public Laws Nos. 19-62, 19-75 and 19-99, is hereby further amended
 19 to read as follows:

20 "Section 6. Allotment and management of funds and lapse
 21 date. All fund appropriated by this act shall be
 22 allotted, managed, administered and accounted for in
 23 accordance with applicable laws including, but not
 24 limited to, the applicable laws, including, but not
 25 limited to, the Financial Management Act of 1979. The

1 allottee shall be responsible for ensuring that these
2 funds, or so much thereof as may be necessary, are used
3 solely for the purpose specified in this act, and that
4 no obligations are incurred in excess of the sum
5 appropriated. The allottee of the funds appropriated
6 under section 2 of this act shall be the Governor of Yap
7 State. The allottee of funds appropriated under
8 sections 3 and 4 of this act shall be the President of
9 the Federated States of Micronesia or his designee;
10 PROVIDED THAT, the allottee of funds appropriated under
11 subsections 3(a), (b), (c), (d), (e), (f), (g), (h),
12 (t), (u), (v), (ag), (ar) and (as) of this act shall be
13 the Mayor of Lelu Town Government or his designee; the
14 allottee of funds appropriated under subsections 3(w),
15 (x), (y), (z), (aa), (ab), (ac), (ad), (ae), (af), (ah),
16 (ai), (aj), (ak), (al), (am), (an), (ao), (ap) and (aq)
17 of this act shall be the Mayor of Tafunsak Municipal
18 Government or his designee; he allottee of funds
19 appropriate under subsections ((1)(a), (b), (c), (e),
20 (f), and 4(2) shall be the Secretary of the Department
21 of Transportation, Communications and Infrastructure or
22 his designee; he allottee of funds appropriated under
23 subsections 4(1)(d), 4(3)(b), 4(3)(d), 4(3)(e) and
24 4(3)(1) shall be the Pohnpei Transportation Authority
25 (PTA). The sllottee of funds appropriated under

1 subsections 5(1), 5(3) and 5(6) of this act shall be the
2 Governor of Chuuk State or his designee. The allottee
3 of funds appropriated under subsection 5(2) of this act
4 shall be the Mortlock Islands Development Authority.
5 The allottee of funds appropriated under subsection 5(4)
6 of this act shall be the Southern Namoneas Development
7 Authority. The allottee of funds appropriated under
8 subsection 5(5) of this act shall be the Faichuk
9 Development Authority. The authority of the allottee to
10 obligate funds appropriated by this act shall lapse on
11 September 30, 2017.”
