

To further amend Public Law No. 20-53, as amended by Public Law No. 20-57, by amending sections 2, 3, 4 and 5 thereof, to change the use and allottee of funds previously appropriated therein, for the purpose of funding priority infrastructure projects and other projects and programs in the states of Kosrae, Pohnpei and Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

6 Section 4. Section 5 of Public Law No. 20-53,
7 as amended by Public Law No. 20-57, is hereby further
8 amended, to read as follows:

9 "Section 5. Allotment and management of funds and lapse
10 date. All funds appropriated by this act shall be
11 allotted, managed, administered and accounted for in
12 accordance with applicable laws, including, but not
13 limited to, the Financial Management Act of 1979. The
14 allottee shall be responsible for ensuring that these
15 funds, or so much thereof as may be necessary, are used
16 solely for the purpose specified in this act, and that no
17 obligations are incurred in excess of the sum
18 appropriated. The allottee of the funds appropriated
19 under sections 2 and 3 of this act shall be the President
20 of the Federated States of Micronesia or his designee;
21 PROVIDED THAT, the allottee of funds appropriated under
22 subsections 2(a) to 2(af) of this act shall be the Mayor
23 of Lelu Town Government or his designee; the allottee of
24 funds appropriated under subsection 2(ag) shall be the
25 Secretary of Education or his designee; the allottee of

1 funds appropriated under subsections 2(ah) to 2(a3) of
2 this act shall be the Mayor of Tafunsak Municipal
3 Government or his designee; the allottee of funds
4 appropriated under subsections 3(1)(a), 3(1)(b), 3(1)(c),
5 3(1)(e), 3(1)(g), 3(1)(j), 3(1)(p), 3(1)(r), 3(2)(b),
6 3(2)(c), 3(2)(d), 3(2)(e), 3(2)(o), 3(3)(d), 3(3)(n),
7 3(3)(t) and 3(3)(x) of this act shall be the Pohnpei
8 Transportation Authority; the allottee of funds
9 appropriated under subsections 3(3)(f), 3(3)(l) and
10 3(3)(m) of this act shall be the Lukenmenlap of Kitti; the
11 allottee of funds appropriated under subsections 3(3)(q)
12 and 3(3)(r) of this act shall be the Pohnpei Utility
13 Corporation; the allottee of fund appropriated under
14 subsections 4(7)(a), 4(7)(b), 4(7)(c), 4(7)(d) and 4(7)(e)
15 shall be the Governor of Chuuk State or his designee. The
16 allottee of the funds appropriated under subsections 4(1),
17 4(3), 4(6) and 4(7) of this act shall be the Governor of
18 Chuuk State or his designee; the allottee of the funds
19 appropriated under subsection 4(2) of this act shall be
20 the Mortlocks Island Development Authority (MIDA); the
21 allottee of the funds appropriated under subsection 4(4)
22 of this act shall be the Southern Namoneas Development
23 Authority; the allottee of the funds appropriated under
24 subsection 4(5) of this act shall be the Faichuk
25 Development Authority. The authority of the allottee to

1 obligate funds appropriated by this act shall lapse on
2 September 30, 2020."

3 Section 5. This act shall become law upon approval by the
4 President of the Federated States of Micronesia or upon its
5 becoming law without such approval.


