

AN ACT

To appropriate the sum of \$1,440,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2018, for the purpose of funding public projects and social programs in the states of Kosrae, Pohnpei and Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$1,440,000, or so much thereof as  
2 my be necessary, is hereby appropriated from the General Fund  
3 of the Federated States of Micronesia for the fiscal year  
4 ending September 30, 2018, for the purpose of funding public  
5 projects and social programs in the states of Kosrae, Pohnpei  
6 and Chuuk. The funds appropriated under this section shall be  
7 apportioned as follows:

8 Section 2. Of the sum of \$1,440,000 appropriated by this  
9 act, \$240,000 is apportioned for public projects and social  
10 programs in the state of Kosrae.

17 Section 5. Allotment and management of funds and lapse date.  
18 All funds appropriated by this act shall be allotted, managed,  
19 administered and accounted for in accordance with applicable laws,  
20 including, but not limited to, the Financial Management Act of  
21 1979. The allottee shall be responsible for ensuring that these  
22 funds, or so much thereof as may be necessary, are used solely for  
23 the purpose specified in this act, and that no obligations are  
24 incurred in excess of the sum appropriated. The allottee of the  
25 funds appropriated under sections 2 and 3 of this act shall be the

1 President of the Federated States of Micronesia or his designee;  
2 PROVIDED THAT the allottee of funds appropriated under subsections  
3 2(a) and 2(b) of this act shall be the Mayor of Lelu Town  
4 Government or his designee; the allottee of funds appropriated  
5 under subsections 2(c) to 2(g) of this act shall be the Mayor of  
6 Tafunsak Municipal Government or his designee; the allottee of  
7 funds appropriation under subsection 3(1)(i) of this act shall be  
8 the Chief Magistrate of Sokehs Municipal Government or his  
9 designee; the allottee of funds appropriated under subsection  
10 3(2)(a) of this act shall be the President of the COM-FSM  
11 Institute or his designee; the allottee of funds appropriated  
12 under subsection 3(2)(b) of this act shall be the Pohnpei  
13 Transportation Authority; the allottee of funds appropriated under  
14 subsections 3(2)(c) to 3(2)(g) of this act shall be the Secretary  
15 of the Department of Transportation, Communications and  
16 Infrastructure or his designee; the allottee of funds appropriated  
17 under subsections 3(4)(a) shall be the President of the COM-FSM  
18 Institute or his designee. The allottee of funds appropriated  
19 under subsections 4(1), 4(3) and 4(6) of this act shall be the  
20 Governor of Chuuk State or his designee. The allottee of funds  
21 appropriated under subsection 4(2) of this act shall be the  
22 Mortlock Islands Development Authority. The allottee of funds  
23 appropriated under subsection 4(4) of this act shall be the  
24 Southern Namoneas Development Authority. The allottee of funds  
25 appropriated under subsection 4(5) of this act shall be the

1 Faichuk Development Authority. The authority of the allottee to  
2 obligate funds appropriated by this act shall lapse on September  
3 30, 2020.

4 Section 6. This act shall become law upon approval by the  
5 President of the Federated States of Micronesia or upon its  
6 becoming law without such approval.


