

AN ACT

To further amend Public Law No. 19-121, as amended by Public Laws Nos. 19-130, 19-142, 20-09, 20-22, 20-51 and 20-59, by amending sections 3 and 6 thereof, to change the use and allottee of funds previously appropriated therein, for the purpose of funding public projects and social programs for the people of the state of Kosrae, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 3 of Public Law No. 19-121, as amended by
2 Public Laws Nos. 19-130, 19-142 and 20-09, is hereby further
3 amended to read as follows:

4 "Section 3. Of the sum of \$5,450,000 appropriated by this
5 act, \$1,100,000 is apportioned to fund public projects and
6 social programs for the people of the state of Kosrae.

25 Section 2. Section 6 of Public Law No. 19-121, as amended by

1 Public Laws Nos. 19-130, 19-142 and 20-09, is hereby further amended
2 to read as follows:

3 "Section 6. Allotment and management of funds and
4 lapse date. All funds appropriated by this act shall
5 be allotted, managed, administered and accounted for
6 in accordance with applicable laws, including, but
7 not limited to, the Financial Management Act of 1979.
8 The allottee shall be responsible for ensuring that
9 these funds, or so much thereof as may be necessary,
10 are used solely for the purpose specified in this
11 act, and that no obligations are incurred in excess
12 of the sum appropriated. The allottee of the funds
13 appropriated under section 2 of this act shall be the
14 Governor of Yap State; PROVIDED THAT, the allottee of
15 funds appropriated under section 2(k) shall be the
16 President of the Federated States of Micronesia. The
17 allottee of funds appropriated under sections 3 and 4
18 of this act shall be the President of the Federated
19 States of Micronesia or his designee; PROVIDED THAT
20 the allottee of funds appropriated under subsections
21 3(a) through 3(z) - shall be the Mayor of Tafunsak
22 Municipal Government; the allottee of funds
23 appropriated under subsections 3(aa) - 3(a11) shall
24 be the Mayor of Lelu Town Government, or his
25 designee; the allottee of funds appropriated under

1 subsections 4(1)(l), 4(3)(a), 4(3)(f) and 4(3)(i) of
2 this act shall be the Pohnpei Transportation
3 Authority (PTA); the allottee of funds appropriated
4 under subsections 4(2)(a), 4(2)(d), 4(2)(e), 4(2)(f),
5 4(2)(g), 4(2)(h), 4(2)(i), 4(2)(j), 4(2)(k), 4(2)(l)
6 and 4(2)(m) shall be the Secretary of the Department
7 of Transportation, Communications and Infrastructure
8 or his designee; the allottee of funds appropriated
9 under subsection 4(2)(b) shall be the Pohnpei Utility
10 Corporation (PUC); the allottee of funds appropriated
11 under subsection 4(2)(c) shall be the Office of
12 Fisheries, Pohnpei State; the allottee of funds
13 appropriated under subsection 4(2)(n) shall be the
14 Secretary of the Department of Education or his
15 designee; the allottee of funds appropriated under
16 subsection 4(3)(b) shall be the Governor of the State
17 of Pohnpei or his designee; the allottee of funds
18 appropriated under subsections 4(3)(c) and 4(3)(e) of
19 this act shall be the Meninkeder of Madolenihmw;
20 allottee of funds appropriated under subsections
21 4(3)(d) and 4(3)(m) shall be the Luhkenmoanlap of
22 Kitti. The allottee of funds appropriated under
23 subsections 5(1), 5(3) and 5(6) of this act shall be
24 the Governor of Chuuk State or his designee. The
25 allottee of funds appropriated under subsection 5(2)

1 of this act shall be the Mortlock Islands Development
2 Authority. The allottee of funds appropriated under
3 subsection 5(4) of this act shall be the Southern
4 Namoneas Development Authority. The allottee of
5 funds appropriated under subsection 5(5) of this act
6 shall be the Faichuk Development Authority. The
7 authority of the allottee to obligate funds
8 appropriated by this act shall lapse on September 30,
9 2018."

10 Section 3. This act shall become law upon approval by the
11 President of the Federated States of Micronesia or upon its
12 becoming law without such approval.
