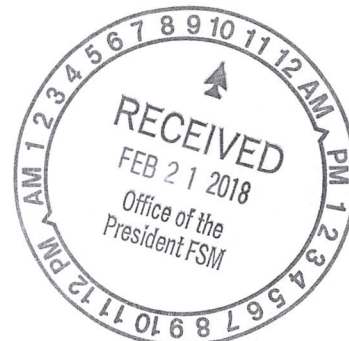



AN ACT

To amend Public Law No. 20-68, by amending section 2 thereof, to change the use of funds previously appropriated therein, to fund public projects and social programs in the state of Kosrae, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 20-68 is hereby
2 amended to read as follows:

3 "Section 2. Of the sum of \$1,440,000 appropriated
4 by this act, \$240,000 is apportioned for public
5 projects and social programs in the state of
