Dear Speaker Simina:

I am pleased to transmit the following Act, which I signed into Public Law No. 20-87:


Congressional Act No. 20-83: "AN ACT TO APPROPRIATE THE SUM OF \$800,000, OR SO MUCH THEREOF AS MAY BE NECESSARY, FROM THE GENERAL FUND OF THE FEDERATED STATES OF MICRONESIA, FOR THE FISCAL YEAR ENDING SEPTEMBER 30, 2018, PREVIOUSLY APPROPRIATED TO FUND PRIORITY INFRASTRUCTURE PROJECTS FOR THE STATE OF KOSRAE, TO FUND PUBLIC PROJECTS AND SOCIAL PROGRAMS IN THE STATE OF KOSRAE, AND FOR OTHER PURPOSES."

While I have signed this Act into law, I have also decided to item veto the \$19,000 funding for the Renovation of Tafunsak multipurpose building (page 2, lines 12 and 13) because this line item would make sense only if there is a multipurpose building in place. Since there is none at the moment, then it would be improper to set aside funding for renovation work.

Moreover, I am vetoing the \$65,000 funding for Outreach/Travel needs (page 2, line 8) for being vague, as there are no standards set out to guide on its implementation, no intended travel destinations and no indication on the users of this funding.

CONGRESSIONAL BILL NO. 20-184, C.D.1

AN ACT

To appropriate the sum of \$800,000, or so much thereof as may be necessary, from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2018, previously appropriated to fund priority infrastructure projects for the state of Kosrae, to fund public projects and social programs in the state of Kosrae, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$800,000, or so much thereof as
2 may be necessary, is hereby appropriated from the General
3 Fund of the Federated States of Micronesia for the fiscal
4 year ending September 30, 2018, previously appropriated to
5 fund priority infrastructure projects for the state of
6 Kosrae, to fund public projects and social programs in the
7 state of Kosrae. The funds appropriated under this section
8 shall be apportioned as follows:

8 Section 2. Allotment and management of funds and lapse date.

9 All funds appropriated by this act shall be allotted, managed,
10 administered and accounted for in accordance with applicable laws,
11 including, but not limited to, the Financial Management Act of
12 1979. The allottee shall be responsible for ensuring that these
13 funds, or so much thereof as may be necessary, are used solely for
14 the purpose specified in this act, and that no obligations are
15 incurred in excess of the sum appropriated. The allottee of the
16 funds appropriated under subsections 1(a) to 1(o) of this act
17 shall be the Mayor of Tafunsak Municipal Government or his
18 designee. The allottee of the funds appropriated under
19 subsections 1(p) to 1(ac) of this act shall be the Mayor of Lelu
20 Town Government or his designee. The authority of the allottee to
21 obligate funds appropriated by this act shall lapse on September
22 30, 2020."

PUBLIC LAW No. 20- 87

1 Section 3. This act shall become law upon approval by the
2 President of the Federated States of Micronesia or upon its
3 becoming law without such approval.


