

AN ACT

To appropriate the sum of \$1,400,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2018, for the purpose of funding public projects and social programs for the people of Yap, Kosrae, Pohnpei and Chuuk states, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$1,400,000, or so much thereof as may
2 be necessary, is hereby appropriated from the General Fund of the
3 Federated States of Micronesia for the fiscal year ending
4 September 30, 2018, for the purpose of funding public projects and
5 social programs for the people of Yap, Kosrae, Pohnpei and Chuuk
6 states. The funds appropriated under this section shall be
7 apportioned as follows:

8 Section 2. Of the \$1,400,000 appropriated under this act,
9 \$200,000 shall be apportioned for public projects and
10 social programs in the state of Yap.

12 Section 6. Allotment and management of funds and lapse date.

13 All funds appropriated by this act shall be allotted, managed,

14 administered and accounted for in accordance with applicable laws,

15 including, but not limited to, the Financial Management Act of

16 1979. The allottee shall be responsible for ensuring that these

17 funds, or so much thereof as may be necessary, are used solely for

18 the purpose specified in this act, and that no obligations are

19 incurred in excess of the sum appropriated. The allottee of the

20 funds appropriated under section 2 of this act shall be the

21 Governor of Yap State or his designee. The allottee of funds

22 appropriated under sections 3 and 4 of this act shall be the

23 President of the Federated States of Micronesia or his designee;

24 PROVIDED THAT, the allottee of funds appropriated under

25 subsections 3(a) to 3(f) of this act shall be the Mayor of

1 Tafunsak Municipal Government or his designee; the allottee of
 2 funds appropriated under subsections 3(g) to 3(m) shall be the
 3 Mayor of Lelu Town Government or his designee; the allottee of
 4 funds appropriated under subsections 4(2)(a) to 4(2)(g) of this
 5 act shall be the Secretary of the Department of Transportation,
 6 Communications and Infrastructure or his designee; the allottee of
 7 funds appropriated under subsection 4(3)(a) of this act shall be
 8 the Speaker of Kitti Municipal Government or his designee; the
 9 allottee of funds appropriated under subsection 4(3)(f) of this
 10 act shall be the Speaker of Madolenihmw Municipal Government or
 11 his designee; the allottee of funds appropriated under subsection
 12 4(4)(e) of this act shall be the Mayor of Mwokilloa Municipal
 13 Government or his designee; the allottee of funds appropriated
 14 under subsections 4(4)(f) of this act shall be the Mayor of
 15 Pingelap Municipal Government or his designee. The allottee of
 16 the funds appropriated under subsections 5(1), 5(3) and 5(6) of
 17 this act shall be the Governor of Chuuk State or his designee; the
 18 allottee of the funds appropriated under subsection 5(2) of this
 19 act shall be the Mortlocks Island Development Authority (MIDA);
 20 the allottee of the funds appropriated under subsection 5(4) of
 21 this act shall be the Southern Namoneas Development Authority; the
 22 allottee of the funds appropriated under subsection 5(5) of this
 23 act shall be the Faichuk Development Authority. The authority of
 24 the allottee to obligate funds appropriated by this act shall
 25 lapse on September 30, 2020."

1 Section 7. This act shall become law upon approval by the
2 President of the Federated States of Micronesia or upon its
3 becoming law without such approval.
