

AN ACT

To appropriate the sum of \$2,800,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2018, for the purpose of funding public projects and social programs for the people of Yap, Kosrae, Pohnpei and Chuuk states, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$2,800,000, or so much thereof as may
2 be necessary, is hereby appropriated from the General Fund of the
3 Federated States of Micronesia for the fiscal year ending
4 September 30, 2018, for the purpose of funding public projects and
5 social programs for the people of Yap, Kosrae, Pohnpei and Chuuk
6 states. The funds appropriated under this section shall be
7 apportioned as follows:

8 Section 2. Of the \$2,800,000 appropriated under this act,

10 programs for the people of Yap State.

22 Section 6. Allotment and management of funds and lapse date.
23 All funds appropriated by this act shall be allotted, managed,
24 administered and accounted for in accordance with applicable laws,
25 including, but not limited to, the Financial Management Act of

1 1979. The allottee shall be responsible for ensuring that these
2 funds, or so much thereof as may be necessary, are used solely for
3 the purpose specified in this act, and that no obligations are
4 incurred in excess of the sum appropriated. The allottee of the
5 funds appropriated under section 2 of this act shall be the
6 Governor of Yap State or his designee, PROVIDED THAT, the allottee
7 of funds appropriated under subsection 2(c) and 2(h) of this act
8 shall be the President of the Federated States of Micronesia or
9 his designee; and PROVIDED THAT the allottee of funds appropriated
10 under subsection 2(a) of this act shall be the President of the
11 COM-FSM or his designee. The allottee of funds appropriated under
12 sections 3 and 4 of this act shall be the President of the
13 Federated States of Micronesia or his designee; PROVIDED THAT, the
14 allottee of funds appropriated under subsections 3(a) to 3(l) of
15 this act shall be the Mayor of Tafunsak Municipal Government or
16 his designee; the allottee of funds appropriated under subsections
17 3(m) to 3(q) of this act shall be the Mayor of Lelu Municipal
18 Government or his designee; the allottee of funds appropriated
19 under subsections 4(1)(e), 4(2)(a), 4(2)(b), 4(2)(d) and 4(2)(f)
20 of this act shall be the Pohnpei Transportation Authority; the
21 allottee of funds appropriated under subsections 4(2)(c) of this
22 act shall be the President of the COM-FSM or his designee; the
23 allottee of funds appropriated under subsection 4(2)(e), 4(2)(g),
24 4(2)(h) and 4(2)(i) of this act shall be the Secretary of the
25 Department of Transportation, Communications and Infrastructure or

1 his designee; the allottee of funds appropriated under subsections
2 4(3)(g) and 4(3)(m) of this act shall be the Lukenmoanlap of
3 Kitti; the allottee of funds appropriated under subsection 4(3)(f)
4 of this act shall be the FSM National Olympic Committee; the
5 allottee of funds appropriated under subsections 4(3)(h) and
6 4(3)(l) of this act shall be the Chief Justice of Madolenihmw; the
7 allottee of funds appropriated under subsection 4(4)(c) of this
8 act shall be the Mayor of Pingelap Municipal Government or his
9 designee; the allottee of funds appropriated under subsection
10 4(4)(d) of this act shall be the Mayor of Mwokilloa Municipal
11 Government or his designee. The allottee of the funds
12 appropriated under subsections 5(1), 5(3) and 5(6) of this act
13 shall be the Governor of Chuuk State or his designee; the allottee
14 of the funds appropriated under subsection 5(2) of this act shall
15 be the Mortlocks Island Development Authority (MIDA); the allottee
16 of the funds appropriated under subsection 5(4) of this act shall
17 be the Southern Namoneas Development Authority; the allottee of
18 the funds appropriated under subsection 5(5) of this act shall be
19 the Faichuk Development Authority. The authority of the allottee
20 to obligate funds appropriated by this act shall lapse on
21 September 30, 2020."


