CONGRESSIONAL BILL NO. 21-137, C.D.1

AN ACT

To further amend Public Law No. 20-31, as amended by Public Laws Nos. 20-41, 20-50, 20-77, 20-113, 21-24 and 21-45, by amending sections 4 and 6 thereof, to change the use and allottee of certain funds previously appropriated therein, to fund public projects and social programs for the people of Pohnpei State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 20-31, as amended
2 by Public Law No. 20-41, is hereby further amended to read as
3 follows:

4 "Section 4. Of the sum of \$4,200,000 appropriated by
5 this act, \$1,200,000 is apportioned for Pohnpei State
6 for public projects and social programs.

19 Section 2. Section 6 of Public Law No. 20-31, as amended
 20 by Public Laws Nos. 20-41 and 21-24, is hereby amended
 21 to read as follows:

22 "Section 6. Allotment and management of funds and
 23 lapse date. All funds appropriated by this act
 24 shall be allotted, managed, administered and
 25 accounted for in accordance with applicable laws,

1 including, but not limited to, the Financial
 2 Management Act of 1979. The allottee shall be
 3 responsible for ensuring that these funds, or so
 4 much thereof as may be necessary, are used solely
 5 for the purpose specified in this act, and that no
 6 obligations are incurred in excess of the sum
 7 appropriated. The allottee of the funds
 8 appropriated under section 2 of this act shall be
 9 the Governor of Yap State or his designee. The
 10 allottee of funds appropriated under sections 3 and
 11 4 of this act shall be the President of the
 12 Federated States of Micronesia or his designee;
 13 PROVIDED THAT the allottee of funds appropriated
 14 under subsections 3(a) to 3(n) of this act shall be
 15 the Mayor of Lelu Town Government or his designee;
 16 the allottee of funds appropriated under
 17 subsections 3(o) to 3(ae) of this act shall be the
 18 Mayor of Tafunsak Municipal Government or his
 19 designee; the allottee of funds appropriated under
 20 subsections 4(1)(f), 4(1)(k), 4(1)(l), 4(1)(m),
 21 4(2)(b) and 4(2)(c) of this act shall be the
 22 Pohnpei Transportation Authority (PTA); the
 23 allottee of funds appropriated under subsections
 24 4(2)(a), 4(2)(d), 4(2)(e), 4(2)(f), 4(2)(g),
 25 4(2)(h), 4(2)(i) and 4(2)(j) shall be the Secretary

1 of the Department of Transportation, Communications
2 and Infrastructure or his designee; 4(3)(g),
3 4(3)(v) and 4(3)(w) of this act shall be the
4 Secretary of Education or his designee; the
5 allottee of funds appropriated under subsections,
6 4(3)(l) and 4(3)(t) of this act shall be the
7 Luhkenmoanlap of Kitti; the allottee of funds
8 appropriated under subsection 4(3)(o) of this act
9 shall be the Pohnpei Utility Corporation; the
10 allottee of funds appropriated under subsection
11 4(3)(j) of this act shall be the Speaker of
12 Madolenihmw Municipal Government or his designee;
13 the allottee of funds appropriated under subsection
14 4(3)(p) of this act shall be the Director of Land
15 Grant Program; the allottee of funds appropriated
16 under subsection 4(3)(r) of this act shall be the
17 Secretary of Health and Social Affairs or her
18 designee; the allottee of funds appropriated under
19 subsection 4(3)(u) of this act shall be the
20 Meninkeder of Madolenihmw. The allottee of funds
21 appropriated under subsections 5(1), 5(3) and 5(6)
22 of this act shall be the Governor of Chuuk State or
23 his designee. The allottee of funds appropriated
24 under subsection 5(2) of this act shall be the
25 Mortlock Islands Development Authority. The

1 allottee of funds appropriated under subsection
2 5(4) of this act shall be the Southern Namoneas
3 Development Authority. The allottee of funds
4 appropriated under subsection 5(5) of this act
5 shall be the Faichuk Development Authority. The
6 authority of the allottee to obligate funds
7 appropriated by this act shall lapse on September
8 30, 2020."

9 Section 3. This act shall become law upon approval by
10 the President of the Federated States of Micronesia or upon its
11 becoming law without such approval.
