

AN ACT

To further amend Public Law No. 8-75, as amended by Public Laws Nos. 8-79, 8-116, 8-145 and 8-149, by further amending section 3, as amended by Public Laws Nos. 8-79, 8-116, 8-145 and 8-149, to change an allottee of funds, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1           Section 1. Section 3 of Public Law No. 8-75, as amended by  
2 Public Laws Nos. 8-79, 8-116, 8-145, and 8-149, is hereby further  
3 amended to read as follows:

4           "Section 3. All funds appropriated by this act shall be  
5 allotted, managed, administered, and accounted for in  
6 accordance with applicable law, including, but not limited  
7 to, the Financial Management Act of 1979. The allottee  
8 of the funds appropriated under subsection (1)(a) of  
9 section 2 of this act shall be the PWP Development  
10 Authority. The allottee of the funds appropriated under  
11 subsections (1)(b)(i), (1)(b)(ii), (1)(b)(iii) and (1)(b)(iv)  
12 of section 2 of this act shall be the Mayor of Fono. The  
13 allottee of the funds appropriated under subsections (1)  
14 (b)(v), (1)(b)(vi) and (1)(b)(vii) of section 2 of this act  
15 shall be the Mayor of Pis-Paneu. The allottee of the funds  
16 appropriated under subsections (1)(b)(viii), (1)(b)(x),  
17 (1)(b)(xi), and (1)(b)(xvii) of section 2 of this act shall be  
18 the Mayor of Weno. The allottee of funds appropriated  
19 under subsections (1)(b)(ix), (1)(b)(xii), (1)(b)(xiii),  
20 (1)(b)(xiv), (1)(b)(xv), (1)(b)(xvi), and (1)(b)(xviii) of  
21 section 2 of this act shall be the Weno Projects  
22 Coordinator. The allottee of the funds appropriated

1 under subsection (1)(c) of section 2 of this act shall be  
2 the Southern Namoneas Development Authority. The  
3 allottee of the funds appropriated under subsection (1)(d)  
4 of section 2 of this act shall be the Lower Mortlocks  
5 Development Authority. The allottee of the funds  
6 appropriated under subsection (1)(e)(i), (1)(e)(ii) and  
7 (1)(e)(iii) of section 2 of this act shall be the Executive  
8 Director of the Hall Development Authority. The allottee  
9 of the funds appropriated under subsections (1)(e)(iv),  
10 (1)(e)(v) and (1)(e)(vi) of section 2 of this act shall be  
11 the Weito Development Authority. The allottee of the  
12 funds appropriated under subsections (1)(e)(vii),  
13 (1)(e)(viii), (1)(e)(ix), (1)(e)(x), (1)(e)(xi)a), (1)(e)(xii),  
14 and (1)(e)(xiii) of section 2 of this act shall be the Pattiw  
15 Development Authority. The allottee of the funds  
16 appropriated under subsections (1)(e)(xi)b) of section 2  
17 of this act shall be the Director of Public Safety for the  
18 State of Chuuk. The allottee of the funds appropriated  
19 under subsections (1)(e)(xi)c) of section 2 of this act  
20 shall be the Director of the Chuuk State Department of  
21 Agriculture. The allottee of the funds appropriated under  
22 subsections (1)(f)(i), (1)(f)(ii) and (1)(f)(vi) of section 2  
23 of this act shall be the Executive Director of COCA. The  
24 allottee of the funds appropriated under subsection  
25 (1)(f)(iii), (1)(f)(iv) and (1)(f)(v) of

1 section 2 of this act shall be the Governor of the State of  
2 Chuuk. The allottee of the funds appropriated under  
3 subsection (1)(f)(vii) of section 2 of this act shall be the  
4 Lower Mortlocks Development Authority. The allottee of  
5 the funds appropriated under subsection (2)(a)(i) of  
6 section 2 of this act shall be the Luhkenkolwof of  
7 Sapwuafik. The allottee of the funds appropriated under  
8 subsection (2)(a)(ii) of section 2 of this act shall be the  
9 Chief Magistrate of Nukuoro. The allottee of the funds  
10 appropriated under subsection (2)(a)(iii) of section 2 of  
11 this act shall be the Chief Magistrate of Kapingamarangi.  
12 The allottee of the funds appropriated under subsection  
13 (2)(a)(iv) of section 2 of this act shall be the Mayor of  
14 Kolonia Town. The allottee of the funds appropriated  
15 under subsections (2)(a)(v)a), (2)(a)(v)b) and 2(a)(v)i)  
16 of section 2 of this act shall be the Chief Magistrate of  
17 Sokehs. The allottee of the funds appropriated under  
18 subsections (2)(b), (2)(c), (2)(e), (2)(f), (4)(b), (4)(c),  
19 (4)(d), (4)(e), (4)(f), (4)(g), (4)(h), (4)(i), (4)(j) and  
20 (4)(k) of section 2 of this act shall be the President of the  
21 Federated States of Micronesia. The allottee of the funds  
22 appropriated under subsections (2)(a)(v)c) of section 2 of  
23 this act shall be the Pohnpei Utility Corporation. The  
24 allottee of funds appropriated under subsection (2)(d) of  
25 section 2 of this act shall be the Pohnpei Transportation

1 Authority. The allottee of the funds appropriated under  
2 subsection 3 of section 2 of this act shall be the Governor  
3 of the State of Yap or his designee. The allottee of the  
4 funds appropriated under subsection (4)(a) of section 2 of  
5 this act shall be the Chairman of the Kosrae Sports  
6 Council. The allottee of the funds appropriated under  
7 subsections (4)(l) and (4)(n) of section 2 of this act shall  
8 be the Mayor of the Lelu Municipal Government. The  
9 allottee of the funds appropriated under subsections  
10 (4)(m) and (4)(o) of section 2 of this act shall be the  
11 Mayor of the Malem Municipal Government. The allottee of  
12 the funds appropriated under subsection (4)(p) of section  
13 2 of this act shall be the President of the Federated  
14 States of Micronesia. The allottee of the funds  
15 appropriated under subsection (4)(q) of section 2 of this  
16 act shall be the Mayor of the Tafunsak Municipal  
17 Government. The allottees shall be responsible for  
18 ensuring that these funds, or so much thereof as may be  
19 necessary, are used solely for the purposes specified in  
20 this act, and that no obligations are incurred in excess of  
21 the sum appropriated. The authority of the allottees to  
22 obligate funds appropriated by this act shall not lapse."

1           Section 2. This act shall become law upon approval by the  
2 President of the Federated States of Micronesia or upon its becoming  
3 law without such approval.
