

AN ACT

To further amend Public Law No. 7-29, as amended by Public Laws No. 7-47 and 8-30, by further amending section 1, as amended by Public Law No. 7-47, and by further amending section 2, as amended by Public Laws Nos. 7-47 and 8-30, to allocate the use of funds previously appropriated therein and to modify the allottee of certain funds appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 7-29, as amended by Public Law  
2 No. 7-47, is hereby further amended to read as follows:

3 "Section 1. The sum of \$1,000,000, or so much thereof as may  
4 be necessary, is hereby appropriated from the General Fund of the  
5 Federated States of Micronesia for the fiscal year ending  
6 September 30, 1992, for the purpose of funding public projects in  
7 the State of Kosrae. The sum appropriated by this section shall be  
8 apportioned as follows:

9 (1) Administrative expenses of the KSCIP

- 10 (a) Personnel.....\$ 5,000
- 11 (b) Travel..... 2,000
- 12 (c) Consumable goods..... 14,000
- 13 (d) Contractual services..... 9,400

14 (2) Lelu municipal projects

- 15 (a) Road construction equipment
- 16 and parts..... 68,000
- 17 (b) Water system maintenance..... 12,000
- 18 (c) Farm project..... 42,000

19 (3) Tafunsak municipal projects

- 20 (a) Road construction equipment
- 21 and parts.....120,000

16 Section 2. Section 2 of Public Law No. 7-29, as amended by Public Laws  
17 Nos. 7-47 and 8-30, is hereby further amended to read as follows:

18 "Section 2. All funds appropriated by this act shall be allotted,  
19 managed, administered, and accounted for in accordance with  
20 applicable law, including, but not limited to, the Financial  
21 Management Act of 1979. The allottee of the funds appropriated  
22 under subsections (1) and (6)(e) of section 1 of this act shall be  
23 the chairman of the KSCIP; the allottee of the funds appropriated  
24 under subsections (2), and (6)(a) of section 1 of this act shall be  
25 the Mayor of Lelu Municipality; the allottee of the funds

1 appropriated under sections (3), (4) and (5) of section 1 of this  
2 act shall be the Mayors of. Tafunsak, Malem, and Utwe  
3 Municipalities, respectively; the allottee of the funds appropriated  
4 under subsections (6)(b), (6)(c), (6)(d) and (7) of section 1 of  
5 this act shall be the Governor of Kosrae State. The allottees shall  
6 be responsible for ensuring that these funds, or so much thereof  
7 as may be necessary, are used solely for the purposes specified in  
8 this act, and that no obligations are incurred in excess of the sum  
9 appropriated. The authority of the allottees to obligate funds  
10 appropriated by this act shall not lapse."

11 Section 3. This act shall become law upon approval by the President of  
12 the Federated States of Micronesia or upon its becoming law without such  
13 approval.
