

AN ACT

To appropriate the sum of \$750,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1995, for medical supplies, equipment, referral programs, and construction and renovation of dispensaries in all of the four States of the Federated States of Micronesia, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF

MICRONESIA:

1 Section 1. The sum of \$400,000, or so much thereof as may be
2 necessary, is hereby appropriated from the General Fund of the Federated
3 States of Micronesia for the fiscal year ending September 30, 1995, for medical
4 supplies, equipment, referral programs, and construction and renovation of
5 dispensaries in the State of Chuuk to be apportioned as follows:

12 Section 2. The sum of \$200,000, or so much thereof as may be
13 necessary, is hereby appropriated from the General Fund of the Federated
14 States of Micronesia for the fiscal year ending September 30, 1995, for
15 pharmaceutical supplies, lab and dental equipment, and referral programs in the
16 State of Pohnpei.

17 Section 3. The sum of \$100,000, or so much thereof as may be
18 necessary, is hereby appropriated from the General Fund of the Federated

1 States of Micronesia for the fiscal year ending September 30, 1995, for medical
2 supplies, equipment, and referral programs in the State of Yap.

3 Section 4. The sum of \$50,000, or so much thereof as may be
4 necessary, is hereby appropriated from the General Fund of the Federated
5 States of Micronesia for medical supplies, equipment, and referral programs in
6 the State of Kosrae.

7 Section 5. All funds appropriated by this act shall be allotted, managed,
8 administered, and accounted for in accordance with applicable law, including, but
9 not limited to, the Financial Management Act of 1979. All funds appropriated
10 herein shall not lapse until fully expended. The allottee of funds appropriated
11 under subsection (1) of section 1 of this act shall be the Director of Health
12 Services, Chuuk State. The allottee of funds appropriated under subsection (2)
13 of section 1 of this act shall be the PWP Authority. The allottee of funds
14 appropriated under subsection (3) of section 1 of this act shall be the Southern
15 Namoneas Authority. The allottee of funds appropriated under subsection (4)
16 of section 1 of this act shall be the Northern Namoneas Development Authority.
17 The allottee of funds appropriated under subsection (5) of section 1 of this act
18 shall be the Mortlocks Development Authority. The allottee of funds
19 appropriated under subsection (6) of section 1 of this act shall be the Pattiw
20 Development Authority. The allottee of funds appropriated under section 2 of
21 this act shall be the Governor of Pohnpei State. The allottee of funds
22 appropriated under section 3 of this act shall be the Governor of Yap State. The
23 allottee of funds appropriated under section 4 of this act shall be the Governor
24 of Kosrae State.
