

AN ACT

To further amend Public Law No. 8-100, as amended by Public Laws Nos. 8-121 and 9-011, by amending section 1 to provide that the funds may be used for other economic and social needs, to specify the use of certain funds appropriated for Northern Namoneas and the Northwest Islands, and by further amending section 6, as amended by Public Law No. 8-121, for the purpose of changing the allottees of the funds appropriated for the districts of Northern Namoneas and the Northwest Islands in the State of Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 8-100 is hereby amended to
2 read as follows:

3 "Section 1. The sum of \$1,400,000, or so much thereof as may
4 be necessary, is hereby appropriated from the General Fund of
5 the Federated States of Micronesia for the fiscal year ending
6 September 30, 1995, for educational needs and other economic
7 and social needs in the State of Chuuk. The funds appropriated
8 under this section shall be disbursed only for educational
9 needs other than travel, and/or vehicles, and shall be
10 apportioned as follows:

12 Section 2. Section 6 of Public Law No. 8-100, as amended by
13 Public Law No. 8-121, is hereby further amended to read as follows:

14 "Section 6. All funds appropriated by this act shall be
15 allotted, managed, administered, and accounted for in
16 accordance with applicable law, including, but not limited
17 to, the Financial Management Act of 1979. The allottee of
18 the funds appropriated under subsections (1), (6), (7), (8),
19 and (9) of section 1 of this act shall be the Secretary of
20 Education. The allottee of the funds appropriated under
21 subsection (2) of section 1 of this act shall be the Lower
22 Mortlocks Development Authority. The allottee of the funds
23 appropriated by subsection (3) of section 1 of this act shall
24 be the Northern Namoneas Development Authority. The allottee
25 of the funds appropriated under subsection (4) of section 1

1 of this act shall be the Southern Namoneas Development
2 Authority. The allottee of the funds appropriated by
3 subsection (5) of section 1 of this act shall be the Pattiw
4 Development Authority. The allottee of the funds
5 appropriated under section 2 of this act shall be the
6 Governor of the State of Kosrae. The allottee of the funds
7 appropriated under subsections (1), (3), and (4) of section 4
8 of this act shall be the Governor of the State of Yap. The
9 allottee of the funds appropriated under subsection (2) of
10 section 4 of this act shall be President of the College of
11 Micronesia-FSM. The allottee of all other funds appropriated
12 by this act shall be the President of the Federated States of
13 Micronesia or the President's designee. The allottees shall
14 be responsible for ensuring that these funds, or so much
15 thereof as may be necessary, are used solely for the purposes
16 specified in this act, and that no obligations are incurred
17 in excess of the sum appropriated. The authority of the
18 allottees to obligate funds appropriated by this act shall
19 not lapse."
