

AN ACT

To further amend Public Law No. 8-113, as amended by Public Laws Nos. 8-129, 8-139 and 9-002, by further amending sections 1, as amended by Public Law No. 8-129, to allocate the funds appropriated for the Faichuk district of Chuuk State, by further amending section 6, as amended by Public Law No. 8-129, for the purpose of changing the allottee of funds previously appropriated for social and economic development projects in the State of Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 8-113, as amended by Public
2 Law No. 8-129, is hereby further amended to read as follows:

3 "Section 1. the sum of \$800,000, or so much thereof as may be
4 necessary, is hereby appropriated from the General Fund of the
5 Federated States of Micronesia for the fiscal year ending
6 September 30, 1995, for the purpose of providing funding for
7 social and economic development projects related to Chuuk
8 State. The funds appropriated by this section shall be
9 apportioned and allocated as follows:

- 10 (1) Faichuk
 - 11 (a) Udot.....\$100,000
 - 12 (b) Tolensom..... 150,000
- 13 (2) Southern Namoneas..... 202,000
- 14 (3) Northern Namoneas..... 120,000
- 15 (4) Mortlocks
 - 16 (a) Social and economic projects
 - 17 grants..... 100,000
 - 18 (b) Land acquisition for Mortlockese
 - 19 community in Guam, to be disbursed only by instrument made
 - 20 payment to a non-profit legal entity duly organized under
 - 21 the laws of Guam, and formed for the purpose of acquiring
 - 22 such land..... 20,000

- 1 (5) North western region project fund is earmarked for
2 (a) The Ruo Airport project.....\$ 60,000
3 (6) Equipment and installation supplemental
4 funds for V6AK..... 10,000
5 (7) Chuuk International Airport water tank,
6 luggage carts and other supplies and equipment for the
7 the airport..... 20,000
8 (8) Chuuk delegation office..... 18,000"

9 Section 2. Section 6 of Public Law No. 8-113, as amended by Public
10 Law No. 8-129, is hereby further amended to read as follows:

11 "Section 6. All funds appropriated by this act shall be
12 allotted, managed, administered, and accounted for in
13 accordance with applicable law, including, but not limited to,
14 the Financial Management Act of 1979. The allottee of the
15 funds appropriated under subsection (1)(a) of section 1 of
16 this act shall be the Mayor of Udot. The allottee of the
17 funds appropriated under subsection (1)(b) of section 1 of
18 this act shall be the Mayor of Tolensom. The allottee of the
19 funds appropriated by subsection (2) of section 1 of this act
20 shall be the Southern Namoneas Authority. The allottee of the
21 funds appropriated by subsection (3) of section 1 of this act
22 shall be the Northern Namoneas Development Authority. The
23 allottee of the funds appropriated by subsection (4) of
24 section 1 of this act shall be the Lower Mortlocks Development
25 Authority. The allottee of the funds appropriated by

1 subsection (5) (a) of section 1 of this act shall be the Pattiw
2 Development Authority. The allottee of the funds appropriated
3 by subsection (6) of section 1 of this act shall be the
4 Executive Director of the Chuuk Organization for Community
5 Action. The allottee of the funds appropriated by subsection
6 (7) of section 1 of this act shall be the Governor of Chuuk
7 State. The allottee of the funds appropriated under
8 subsection (8) of section 1 of this act shall be the Speaker
9 of the Congress of the Federated States of Micronesia. The
10 allottee of the funds appropriated by sections 2, 4 and 5 of
11 this act shall be the President of the Federated States of
12 Micronesia, or the President's designee. The allottee of the
13 funds appropriated under section 3 of this act shall be the
14 Governor of the State of Yap. The allottees shall be
15 responsible for ensuring that these funds, or so much thereof
16 as may be necessary, are used solely for the purposes
17 specified in this act, and that no obligations are incurred in
18 excess of the sum appropriated. The authority of the
19 allottees to obligate funds appropriated by this act shall not
20 lapse."
