

AN ACT

To further amend Public Law No. 22-89, as amended by Public Laws Nos. 22-167 and 23-90, by amending sections 1 and 2 thereof, to change the use and extend the lapse date of funds previously appropriated therein, to fund priority infrastructure projects for the people of Yap State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1Section 1. Section 1 of Public Law No. 22-89, as amended

2by Public Laws No. 22-167 and 23-90, is hereby further amended to

3read as follows:

4"Section 1. The sum of \$400,000, or so much thereof as

5may be necessary, is hereby appropriated from the

6General Fund of the Federated States of Micronesia for

7the fiscal year ending September 30, 2022, to provide

8supplemental funding for priority infrastructure

9projects for the people of Yap State. The funds

10appropriated under this section shall be apportioned as

11follows:

12State of Yap..... \$ 400,000

13(a) Assistance for Mortuary Services in

14Yap - Base Charge Only..... 20,000

15(b) Assistance for Repatriation of Deceased Yapese

16Abroad to Yap State..... 40,000

17(c) Council of Tamol Vehicle..... 35,000

18(d) Fais Community Flatbed Truck(s) to

1	be used on Fais Island	\$ 10,000
2	(e) Fuel and Provision for National	
3	Government Vessels Providing Field Trip	
4	Services to the Outer Islands of Yap.....	75,000
5	(f) Gilfith, Fanif Youth Park	
6	Improvement Project.....	100,000
7	(g) Lamotrek Women's Association	
8	Flatbed Truck	10,000

17 Section 2. Section 2 of Public Law No. 22-89, as amended by
18 Public Laws Nos. 22-167 and 23-90, is hereby further amended to
19 read as follows:

20 "Section 2. Allotment and management of funds and lapse
21 date. All funds appropriated by this act shall be
22 allotted, managed, administered and accounted for in
23 accordance with applicable laws, including, but not
24 limited to, the Financial Management Act of 1979. The
25 allottee shall be responsible for ensuring that these

1 funds, or so much thereof as may be necessary, are used
2 solely for the purpose specified in this act, and that
3 no obligations are incurred in excess of the sum
4 appropriated. The allottee of the funds appropriated
5 under section 1 of this act shall be the Governor of Yap
6 State or his designee. The authority of the allottee to
7 obligate funds appropriated by this act shall lapse on
8 September 30, 2028."

9 Section 3. This act shall become law upon approval by the
10 President of the Federated States of Micronesia or upon its
11 becoming law without such approval.
