I am pleased to transmit the following Congressional Act, which I have signed into Public Law No. 20-108:

Congressional Act No. 20-106, entitled: "AN ACT TO FURTHER AMEND PUBLIC LAW NO. 16-49, AS AMENDED BY PUBLIC LAWS NOS. 16-68, 16-76, 17-06, 17-10, 17-23, 17-30, 17-32, 17-45, 17-82, 17-85, 18-28, 18-45, 18-59, 18-86, 19-11, 19-106 AND 19-110 BY CHANGING THE LAPSE DATE OF CERTAIN FUNDS PREVIOUSLY APPROPRIATED THEREIN, TO FUND PUBLIC PROJECTS AND SOCIAL PROGRAMS IN EACH STATES, AND FOR OTHER PURPOSES."

The only change in this act is to extend the lapse date, from September 30, 2018, to September 30, 2019, of funds for public projects and social programs appropriated by Congress in 2010. Thank you.

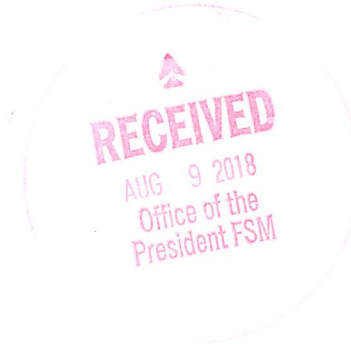

AN ACT

To further amend Public Law No. 16-49, as amended by Public Laws Nos. 16-68, 16-76, 17-06, 17-10, 17-23, 17-30, 17-32, 17-45, 17-82, 17-85, 18-28, 18-45, 18-59, 18-86, 19-11, 19-106 and 19-110 by amending section 6 thereof, for the purpose of changing the lapse date of certain funds previously appropriated therein, to fund public projects and social programs in each of the states, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1           Section 1. Section 6 of Public Law No. 16-49, as amended by  
2 Public Laws Nos. 17-10, 17-45, 17-85, 18-28, 18-86, 19-11, 19-106  
3 and 19-110 is further hereby amended to read as follows:

4           "Section 6. Allotment and management of funds and lapse  
5           date. All funds appropriated by this act shall be  
6           allotted, managed, administered and accounted for in  
7           accordance with applicable law, including, but not  
8           limited to, the Financial Management Act of 1979. The  
9           allottee shall be responsible for ensuring that these  
10          funds, or so much thereof as may be necessary, are used  
11          solely for the purpose specified in this act, and that no  
12          obligations are incurred in excess of the sum  
13          appropriated. The allottee of funds appropriated under  
14          sections 2 and 4 of this act shall be the President of  
15          the Federated States of Micronesia or his designee;  
16          PROVIDED THAT the allottee of funds appropriated under  
17          section 4(1)(b) shall be the Pohnpei Transportation

1 Authority and the allottee of the funds appropriated  
2 under section 4(1)(j) shall be the Mayor of Kolonia Town  
3 Government. The allottee of funds appropriated under  
4 section 3 of this act shall be the Governor of Yap State.  
5 The allottee of funds appropriated under subsections  
6 5(1), 5(3), 5(6) and 5(7) of this act shall be the  
7 Governor of Chuuk State or his designee. The allottee of  
8 funds appropriated under subsection 5(2) of this act  
9 shall be the Mortlock Islands Development Authority  
10 (MIDA). The allottee of funds appropriated under  
11 subsection 5(4) of this act shall be the Southern  
12 Namoneas Development Authority. The allottee of funds  
13 appropriated under subsection 5(5) of this act shall be  
14 the Faichuk Development Authority. The funds  
15 appropriated by this act shall lapse on September 30,  
16 2019.”


