
Dear Speaker Simina:

Congressional Act No. 20-109, entitled: "AN ACT TO FURTHER AMEND PUBLIC LAW NO. 19-170, AS AMENDED BY PUBLIC LAW NO. 20-02, BY AMENDING SECTION 6 THEREOF, TO CHANGE THE LAPSE DATE OF FUNDS PREVIOUSLY APPROPRIATED THEREIN, FOR THE PURPOSE OF FUNDING PUBLIC PROJECTS AND SOCIAL PROGRAMS IN EACH OF THE STATES, AND FOR OTHER PURPOSES."

It is extending to September 30, 2019, from September 30, 2018, the lapse date of the \$200,000 appropriation for public projects and social programs in all the four FSM States passed by the Nineteenth Congress in 2017. Thank you.

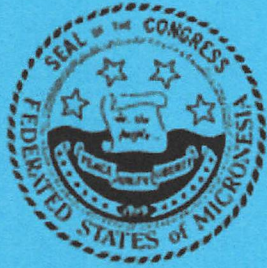

AN ACT

To further amend Public Law No. 19-170, as amended by Public Law No. 20-02, by amending section 6 thereof, to change the lapse date of funds previously appropriated therein, for the purpose of funding public projects and social programs in each of the states, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 6 of Public Law No. 19-170 is hereby
2 amended to read as follows:

3 "Section 6. Allotment and management of funds and lapse
4 date. All funds appropriated by this act shall be allotted,
5 managed, administered and accounted for in accordance with
6 applicable laws, including, but not limited to, the Financial
7 Management Act of 1979. The allottee shall be responsible for
8 ensuring that these funds, or so much thereof as may be
9 necessary, are used solely for the purpose specified in this
10 act, and that no obligations are incurred in excess of the sum
11 appropriated. The allottee of the funds appropriated under
12 section 2 of this act shall be the Governor of Yap State or his
13 designee. The allottee of funds appropriated under sections 3
14 and 4 of this act shall be the President of the Federated
15 States of Micronesia or his designee; PROVIDED THAT, the
16 allottee of funds appropriated under subsection 3(a) of this
17 act shall be the Mayor of Lelu Town Government or his designee.
18 The allottee of funds appropriated under section 5 of this act

1 shall be the Governor of Chuuk State or his designee. The
2 authority of the allottee to obligate funds appropriated by
3 this act shall lapse on September 30, 2019."

4 Section 2. This act shall become law upon approval by the
5 President of the Federated States of Micronesia or upon its
6 becoming law without such approval.
