

AN ACT

To amend Public Law No. 20-93, by amending sections 1 and 2 thereof, to change use and allottee of funds previously appropriated therein, to fund priority infrastructure projects and other public projects and social programs in the state of Kosrae, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 20-93 is hereby  
2 amended to read as follows:

3 "Section 1. The sum of \$800,000, or so much thereof  
4 as may be necessary, is hereby appropriated from the  
5 General Fund of the Federated States of Micronesia  
6 for the fiscal year ending September 30, 2018,  
7 previously appropriated to fund priority  
8 infrastructure projects for the state of Kosrae, to  
9 fund public projects and social programs in the state  
10 of Kosrae. The funds appropriated under this section  
11 shall be apportioned as follows:


15 Section 2. Section 6 of Public Law No. 20-93 is hereby  
 16 amended to read as follows:


17 "Section 6. Allotment and management of funds and lapse  
 18 date. All funds appropriated by this act shall be  
 19 allotted, managed, administered and accounted for in  
 20 accordance with applicable laws, including, but not  
 21 limited to, the Financial Management Act of 1979. The  
 22 allottee shall be responsible for ensuring that these  
 23 funds, or so much thereof as may be necessary, are used  
 24 solely for the purpose specified in this act, and that  
 25 no obligations are incurred in excess of the sum

1           appropriated. The allottee of the funds appropriated  
2           under subsections 1(a) to 1(o) of this act shall be the  
3           Mayor of Tafunsak Municipal Government or his designee.  
4           The allottee of the funds appropriated under subsections  
5           1(p) to 1(ag) of this act shall be the Mayor of Lelu  
6           Town Government or his designee. The authority of the  
7           allottee to obligate funds appropriated by this act  
8           shall lapse on September 30, 2020."

9           Section 3. This act shall become law upon approval by the  
10          President of the Federated States of Micronesia or upon its  
11          becoming law without such approval.
