





CONGRESSIONAL BILL NO. 20-234, C.D.1

AN ACT

To appropriate the sum of \$7,000,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2018, for the purpose of funding public projects and social programs for the people of Yap, Kosrae, Pohnpei and Chuuk states, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$7,000,000, or so much thereof as may
2 be necessary, is hereby appropriated from the General Fund of the
3 Federated States of Micronesia for the fiscal year ending
4 September 30, 2018, for the purpose of funding public projects and
5 social programs for the people of Yap, Kosrae, Pohnpei and Chuuk
6 states. The funds appropriated under this section shall be
7 apportioned as follows:

8 Section 2. Of the \$7,000,000 appropriated under this act,
9 \$1,000,000 shall be apportioned for public projects and social
10 programs for the people of Yap State.

10 Section 6. Allotment and management of funds and lapse date.
 11 All funds appropriated by this act shall be allotted, managed,
 12 administered and accounted for in accordance with applicable laws,
 13 including, but not limited to, the Financial Management Act of
 14 1979. The allottee shall be responsible for ensuring that these
 15 funds, or so much thereof as may be necessary, are used solely for
 16 the purpose specified in this act, and that no obligations are
 17 incurred in excess of the sum appropriated. The allottee of the
 18 funds appropriated under section 2 of this act shall be the
 19 Governor of Yap State or his designee. The allottee of funds
 20 appropriated under sections 3 and 4 of this act shall be the
 21 President of the Federated States of Micronesia or his designee;
 22 PROVIDED THAT, the allottee of funds appropriated under
 23 subsections 3(a) to 3(q) of this act shall be the Mayor of Lelu
 24 Town Government or his designee; the allottee of funds
 25 appropriated under subsection 4(2)(j) of this act shall be the

1 President of the COM-FSM College or his designee; the allottee of
2 funds appropriated under subsection 4(2)(p) of this act shall be
3 the Pohnpei Utility Corporation; the allottee of funds
4 appropriated under subsections
5 4(2)(a),(b),(c),(d),(e),(f)(g),(h),(i),(k),(l),(m),
6 (n),(o),(q),(r),(s), of this act shall be the Secretary of the
7 Department of Transportation, Communications and Infrastructure or
8 his designee. The allottee of the funds appropriated under
9 subsections 5(1), 5(3) and 5(6) of this act shall be the Governor
10 of Chuuk State or his designee; the allottee of the funds
11 appropriated under subsection 5(2) of this act shall be the
12 Mortlocks Island Development Authority (MIDA); the allottee of the
13 funds appropriated under subsection 5(4) of this act shall be the
14 Southern Namoneas Development Authority; the allottee of the funds
15 appropriated under subsection 5(5) of this act shall be the
16 Faichuk Development Authority. The authority of the allottee to
17 obligate funds appropriated by this act shall lapse on September
18 30, 2020.


