AN ACT

To amend Public Law No. 20-93, as amended by Public Laws Nos. 20-98 and 20-120, by amending section 1 thereof, to change use of funds previously appropriated therein, to fund priority infrastructure projects and other public projects and social programs in the state of Kosrae, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 20-93, as
2 amended by Public Laws Nos. 20-98 and 20-120, is hereby
3 further amended to read as follows:

4 "Section 1. The sum of \$800,000, or so much thereof
5 as may be necessary, is hereby appropriated from
6 the General Fund of the Federated States of
7 Micronesia for the fiscal year ending September 30,
8 2018, previously appropriated to fund priority
9 infrastructure projects for the state of Kosrae, to
10 fund public projects and social programs in the
11 state of Kosrae. The funds appropriated under this
12 section shall be apportioned as follows:
