
Dear Speaker Simina:

AN ACT

To amend section 802, as created by Public Law No. 18-34, of title 25 of the Code of the Federated States on Micronesia (Annotated), as amended, by adding a new subsection 3, to clarify responsibilities pertaining to climate change of successor agencies to OEEM, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 802, as created by Public Law No. 18-34,
2 of title 25 of the Code of the Federated States of Micronesia
3 (Annotated), as amended, is hereby amended by adding a new
4 subsection (3) to read as follows:

5 "Section 802. Mainstreaming of Obligations.

6 (1) By October 1, 2014, the following
7 departments and agencies shall prepare plans and
8 policies on climate change consistent with the
9 provisions of the CC policy:

- 10 -Department of Resources and Development;
11 -Office of Environment and Emergency Management;
12 - Department of Transportation, Communications,
13 and Infrastructure;
14 - Department of Heath and Social Affairs;
15 -Department of Education;
16 -Department of Finance and Administration;
17 -Office of Statistics, Budget and Economic
18 Management; and

1 -Department of Foreign Affairs;

2 (2) The Office of Environment and Emergency

3 Management shall coordinate the implementation of the

4 CCF policy; and gather, make publicly available, and

5 keep the required plans and policies from the

6 departments and agencies mentioned in subsection (1).

7 (3) Should the Office of Environment and Emergency

8 Management be changed, renamed or merged into another

9 agency of the National Government, the successor agency,

10 including the Department of Environment, Climate Change

11 and Emergency Management and any subsequent agency

12 dealing primarily with climate change shall be charged

13 with all duties and responsibilities of the former OEEM

14 under this Chapter 8."


