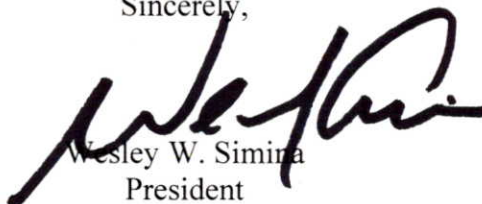
Dear Speaker Moses:

AN ACT

To further amend Public Law No. 20-31, as amended by Public Laws Nos. 20-41, 20-50, 20-77, 20-113, 21-24, 21-45, 21-83, 21-101, 21-133, 21-204, 21-220, 22-79, 22-113, 22-150, 23-65, 23-136, 23-165, 24-08, and 24-42, by amending sections 2 and 6 thereof, to change the use and extend the lapse date of certain funds previously appropriated therein, to fund public projects and social programs for the people of Yap State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 20-31, as amended by
2 Public Laws Nos 20-41 and 21-133, is hereby further amended to read
3 as follows:

4 "Section 2. Of the sum of \$4,200,000 appropriated by this
5 act, \$600,000 is apportioned for Yap State for public
6 projects and social programs.

16 Section 2. Section 6 of Public Law No. 20-31, as amended by

17 Public Laws Nos. 20-41, 21-24, 21-83, 21-133, 21-204, 22-113,

18 23-65, 24-08, and 24-42, is hereby further amended to read as

19 follows:

20 "Section 6. Allotment and management of funds and

21 lapse date. All funds appropriated by this act shall

22 be allotted, managed, administered and accounted for

23 in accordance with applicable laws, including, but not

24 limited to, the Financial Management Act of 1979. The

25 allottee shall be responsible for ensuring that these

1 funds, or so much thereof as may be necessary, are
2 used solely for the purpose specified in this act, and
3 that no obligations are incurred in excess of the sum
4 appropriated. The allottee of the funds appropriated
5 under section 2 of this act shall be the Governor of
6 Yap State or his designee. The allottee of funds
7 appropriated under sections 3 and 4 of this act shall
8 be the President of the Federated States of Micronesia
9 or his designee; PROVIDED THAT the allottee of funds
10 appropriated under subsections 3(a) to 3(n) of this
11 act shall be the Mayor of Lelu Town Government or his
12 designee; the allottee of funds appropriated under
13 subsections 3(o) to 3(ae) of this act shall be the
14 Governor of Kosrae State or his designee; the allottee
15 of funds appropriated under subsections 4(1)(f),
16 4(1)(k), 4(1)(l), 4(1)(m), 4(2)(b), 4(2)(c) and
17 4(3)(y) of this act shall be the Pohnpei
18 Transportation Authority (PTA); the allottee of funds
19 appropriated under subsections 4(2)(a), 4(2)(d),
20 4(2)(e), 4(2)(f), 4(2)(g), 4(2)(h), 4(2)(i) and
21 4(2)(j) shall be the Secretary of the Department of
22 Transportation, Communications and Infrastructure or
23 his designee; 4(3)(g), 4(3)(v) and 4(3)(w) of this act
24 shall be the Secretary of Education or his designee;
25 the allottee of funds appropriated under subsections,

1 4(3)(l) and 4(3)(t) of this act shall be the
2 Luhkenmoanlap of Kittu; the allottee of funds
3 appropriated under subsection 4(3)(o) of this act
4 shall be the Pohnpei Utility Corporation; the allottee
5 of funds appropriated under subsection 4(3)(j) of this
6 act shall be the Speaker of Madolenihmw Municipal
7 Government or his designee; the allottee of funds
8 appropriated under subsection 4(3)(p) of this act
9 shall be the Director of Land Grant Program; the
10 allottee of funds appropriated under subsection
11 4(3)(r) of this act shall be the Secretary of Health
12 and Social Affairs or her designee; the allottee of
13 funds appropriated under subsection 4(3)(u) of this
14 act shall be the Meninkeder of Madolenihmw. The
15 allottee of funds appropriated under subsection
16 4(3)(z) of this act shall be the Chief Justice of
17 Madolenihmw Municipal Government or his designee. The
18 allottee of funds appropriated under subsection 5(1)
19 and 5(6) of this act shall be the Governor of Chuuk
20 State or his designee. The allottee of funds
21 appropriated under subsection 5(2) of this act shall
22 be the Mortlock Islands Development Authority. The
23 allottee of funds appropriated under subsection 5(3)
24 of this act shall be the Mayor of Weno Municipal
25 Government or his designee. The allottee of funds

appropriated under subsection 5(4) of this act shall be the Southern Namoneas Development Authority. The allottee of funds appropriated under subsection 5(5) of this act shall be the Faichuk Development Authority. The authority of the allottee to obligate funds appropriated by this act shall lapse on September 30, 2028."

Section 3. This act shall become law upon approval by the President of the Federated States of Micronesia or upon its becoming law without such approval.
