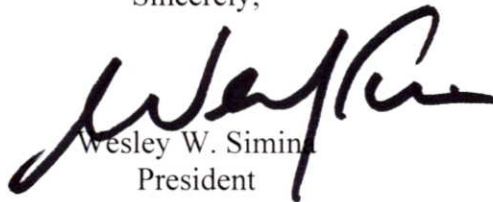
Dear Speaker Moses:

CONGRESSIONAL BILL NO. 24-137

AN ACT

To further amend Public Law No. 20-92, as amended by Public Laws Nos. 20-124, 20-161, 20-171, 21-41, 21-68, 21-134, 21-203, 22-117, 22-193, 23-96, and 24-11, by amending section 6 thereof, for the purpose of extending the lapse date of funds previously appropriated therein, to fund public projects and social programs for the people of Yap, Kosrae, Pohnpei, and Chuuk States, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 6 of Public Law No. 20-92, as amended by
2 Public Laws Nos. 20-124, 21-134, 21-203, 22-117, 23-96, and 24-
3 11, is hereby further amended to read as follows:

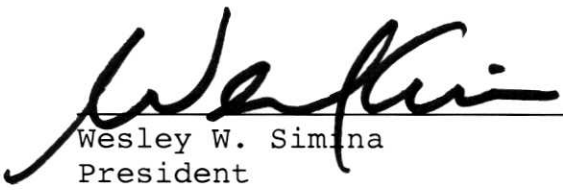
4 "Section 6. Allotment and management of funds and lapse
5 date. All funds appropriated by this act shall be
6 allotted, managed, administered and accounted for in
7 accordance with applicable laws, including, but not
8 limited to, the Financial Management Act of 1979. The
9 allottee shall be responsible for ensuring that these
10 funds, or so much thereof as may be necessary, are used
11 solely for the purpose specified in this act, and that
12 no obligations are incurred in excess of the sum
13 appropriated. The allottee of the funds appropriated
14 under section 2 of this act shall be the Governor of Yap
15 State or his designee; PROVIDED THAT, the allottee of
16 funds appropriated under subsection 2(a) of this act
17 shall be the President of COM-FSM or his designee. The

1 allottee of funds appropriated under sections 3 and 4 of
2 this act shall be the President of the Federated States
3 of Micronesia or his designee; PROVIDED THAT, the
4 allottee of funds appropriated under subsections 3(a),
5 3(b), 3(c), 3(e) and 3(f) of this act shall be the
6 Governor of Kosrae State or his designee; the allottee
7 of funds appropriated under section 3(d) of this act
8 shall be the Mayor of Malem Municipal Government or his
9 designee; the allottee of funds appropriated under
10 subsections 3(g) to 3(m) shall be the Mayor of Lelu Town
11 Government or his designee; the allottee of funds
12 appropriated under subsections 4(2)(a) to 4(2)(g) of
13 this act shall be the Secretary of the Department of
14 Transportation, Communications and Infrastructure or his
15 designee; the allottee of funds appropriated under
16 subsection 4(3)(a) of this act shall be the Speaker of
17 Kitti Municipal Government or his designee; the allottee
18 of funds appropriated under subsection 4(3)(f) of this
19 act shall be the Speaker of Madolenihmw Municipal
20 Government or his designee; the allottee of funds
21 appropriated under subsection 4(4)(e) of this act shall
22 be the Mayor of Mwokilloa Municipal Government or his
23 designee; the allottee of funds appropriated under
24 subsections 4(4)(f) of this act shall be the Mayor of
25 Pingelap Municipal Government or his designee. The

1 allottee of the funds appropriated under subsections
2 5(1) and 5(6) of this act shall be the Governor of Chuuk
3 State or his designee; the allottee of the funds
4 appropriated under subsection 5(2) of this act shall be
5 the Mortlocks Island Development Authority (MIDA); the
6 allottee of funds appropriated under subsection 5(3) of
7 this act shall be the Mayor of Weno Municipal Government
8 or his designee; the allottee of the funds appropriated
9 under subsection 5(4) of this act shall be the Southern
10 Namoneas Development Authority; the allottee of the
11 funds appropriated under subsection 5(5) of this act
12 shall be the Faichuk Development Authority. The
13 authority of the allottee to obligate funds appropriated
14 by this act shall lapse on September 30, 2028."

15 Section 2. This act shall become law upon approval by the
16 President of the Federated States of Micronesia or upon its
17 becoming law without such approval.
