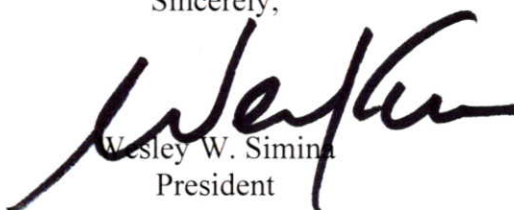
Dear Speaker Moses:

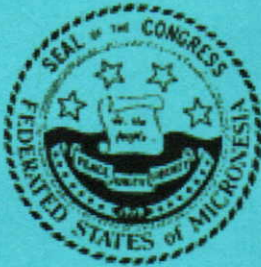

CONGRESSIONAL BILL NO. 24-145

AN ACT

To further amend Public Law No. 21-201, as amended by Public Laws Nos. 21-219, 21-223, 21-229, 21-241, 22-14, 22-28, 22-31, 22-51, 22-67, 22-97, 22-104, 23-21, 23-58, 23-109, 23-127, 23-151, 23-157, and 24-30, by amending section 6 thereof, for the purpose of extending the lapse date of funds previously appropriated therein, to fund priority infrastructure projects and other public projects and social programs for the people of Yap, Kosrae, Pohnpei and Chuuk States, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 6 of Public Law No. 21-201, as amended by
2 Public Laws Nos. 21-219, 22-51, 23-21, 23-109, 23-151, and 24-30,
3 is hereby further amended to read as follows:

4 "Section 6. Allotment and management of funds and lapse
5 date. All funds appropriated by this act shall be
6 allotted, managed, administered and accounted for in
7 accordance with applicable laws, including, but not
8 limited to, the Financial Management Act of 1979. The
9 allottee shall be responsible for ensuring that these
10 funds, or so much thereof as may be necessary, are used
11 solely for the purpose specified in this act, and that
12 no obligations are incurred in excess of the sum
13 appropriated. The allottee of the funds appropriated
14 under section 2 of this act shall be the Governor of Yap
15 State or his designee. The allottee of funds
16 appropriated under sections 3 and 4 of this act shall be

1 the President of the Federated States of Micronesia or
2 his designee; PROVIDED THAT the allottee of funds
3 appropriated under subsection 3(1) of this act shall be
4 the Governor of Kosrae State or his designee; the
5 allottee of funds appropriated under subsection 3(2) of
6 this act shall be the Mayor of Lelu Town Government or
7 his designee; the allottee of funds appropriated under
8 subsections 4(1) and 4(2) of this act shall be the
9 Secretary of the Department of Transportation,
10 Communications and Infrastructure or his designee;
11 EXCEPT THAT the allottee of funds appropriated under
12 subsections 4(2)(a), 4(2)(b), 4(2)(c), 4(2)(e), 4(2)(h),
13 4(2)(i), 4(2)(j), 4(2)(k) and 4(3)(u) of this act shall
14 be the Pohnpei Transportation Authority; the allottee of
15 funds appropriated under subsection 4(2)(d) of this act
16 shall be the President of the COM-FSM, the allottee of
17 funds appropriated under subsection 4(2)(g) of this act
18 shall be the FSM Telecommunications Corporation. The
19 allottee of funds appropriated under subsections
20 4(3)(a), 4(3)(b), 4(3)(d), 4(3)(f), 4(3)(i), 4(3)(m),
21 4(3)(p), and 4(3)(t) of this act shall be the Pohnpei
22 Transportation Authority; the allottee of funds
23 appropriated under subsections 4(3)(c), 4(3)(e),
24 4(3)(g), 4(3)(h), 4(3)(j), 4(3)(k), 4(3)(l), and 4(3)(o)
25 of this act shall be the Meninkeder of Madolenihmw; the

1 allottee of funds appropriated under subsections 4(3)(n)
2 and 4(3)(q) of this act shall be the Secretary of the
3 Department of Health and Social Affairs or his designee;
4 the allottee of funds appropriated under subsections
5 4(3)(r) and 4(3)(s) of this act shall be the Vice
6 President of the Federated States of Micronesia; The
7 allottee of the funds appropriated under subsections
8 5(1), 5(2)(j) and 5(6) of this act shall be the Governor
9 of Chuuk State or his designee; the allottee of the
10 funds appropriated under subsection 5(2) of this act
11 shall be the Mortlocks Island Development Authority
12 (MIDA); the allottee of funds appropriated under
13 subsection 5(3) of this act shall be the Mayor of Weno
14 Municipal Government or his designee the allottee of the
15 funds appropriated under subsection 5(4) of this act
16 shall be the Southern Namoneas Development Authority;
17 the allottee of the funds appropriated under subsection
18 5(5) of this act shall be the Faichuk Development
19 Authority. The authority of the allottee to obligate
20 funds appropriated by this act shall lapse on September
21 30, 2028."

1 Section 2. This act shall become law upon approval by the
2 President of the Federated States of Micronesia or upon its becoming
3 law without such approval.
