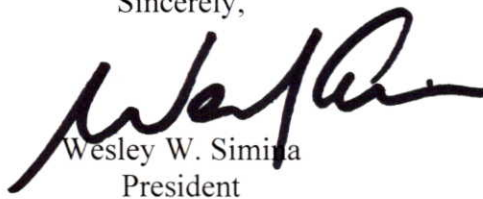
Dear Speaker Moses:

AN ACT

To further amend Public Law No. 22-86, as amended by Public Laws Nos. 22-101, 22-102, 22-106, 22-140, 22-147, 22-168, 22-185, 22-197, 23-06, 23-12, 23-39, 23-50, 23-64, 23-114, 23-135, 23-148, 23-166, 24-04, and 24-21, by amending sections 5 and 6 thereof, to change the use and extend the lapse date of funds previously appropriated therein, for the purpose of funding priority infrastructure projects and other public projects and social programs for the people of Yap, Kosrae, Pohnpei, and Chuuk States, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 5 of Public Law No. 22-86, as amended by
2 Public Laws Nos. 22-101, 22-102, 22-106, 22-147, 22-185, 23-12,
3 23-39, 23-64 and 24-21, is hereby further amended to read
4 as follows:

5 "Section 5. Of the \$11,200,000 appropriated under this
6 act, \$4,800,000 shall be apportioned for priority
7 infrastructure projects and other public projects and
8 social programs for the people of Chuuk State.

16 Section 2. Section 6 of Public Law No. 22-86, as amended by
 17 Public Laws Nos. 22-102, 22-140, 22-168, 23-12, 23-39, 23-64,
 18 and 24-21, is hereby further amended to read as follows:

19 "Section 6. Allotment and management of funds and lapse
 20 date. All funds appropriated by this act shall be
 21 allotted, managed, administered and accounted for in
 22 accordance with applicable laws, including, but not
 23 limited to, the Financial Management Act of 1979. The
 24 allottee shall be responsible for ensuring that these
 25 funds, or so much thereof as may be necessary, are used

solely for the purpose specified in this act, and that no obligations are incurred in excess of the sum appropriated. The allottee of the funds appropriated under section 2 of this act shall be the Governor of Yap State or his designee. The allottee of funds appropriated under subsection 3(1) of this act shall be the Governor of the State of Kosrae or his designee; EXCEPT THAT the allottee of funds appropriated under section 3(1)(q) of this act shall be the Mayor of Malem Municipal Government or his designee; the allottee of funds appropriated under subsection 3(2) of this act shall be the Mayor of Lelu Town Government or his designee. The allottee of funds appropriated under section 4 of this act shall be the President of the Federated States of Micronesia or his designee; PROVIDED THAT, the allottee of funds appropriated under subsection 4(1)(c) of this act shall be the FSM Telecommunication Corporation; the allottee of funds appropriated under subsection 4(1)(g) of this act shall be the Pohnpei Utility Corporation (PUC); the allottee of funds appropriated under subsections 4(1)(a), 4(2)(a), 4(2)(b), 4(2)(c), 4(2)(e), 4(2)(f), 4(2)(h), 4(2)(i), 4(2)(j), 4(2)(l), 4(3)(b), 4(3)(c), 4(3)(d), 4(3)(e) 4(3)(f), 4(3)(q), 4(3)(r) and 4(3)(ac) of this act shall be the Pohnpei Transportation Authority (PTA);

1 the allottee of funds appropriated under subsections
2 4(1)(j), 4(2)(d) and 4(3)(l) of this act shall be the
3 Secretary of the Department of Resources and Development
4 or her designee; the allottee of the funds appropriated
5 under subsections 4(1)(b), 4(1)(d), 4(1)(e), 4(1)(f),
6 4(1)(h), 4(1)(k), 4(1)(l), 4(1)(m), 4(1)(n), 4(2)(g),
7 4(3)(a), 4(3)(g), 4(3)(h), 4(3)(j) 4(3)(k), 4(3)(p),
8 4(3)(s) , 4(3)(u), 4(3)(z), 4(3)(aa) and 4(3)(ab), of
9 this act shall be the Secretary of the Department of
10 Transportation, Communications and Infrastructure or his
11 designee; the allottee of funds appropriated under
12 subsection 4(2)(k) of this act shall be the President of
13 the COM-FSM or his designee; the allottee of funds
14 appropriated under subsections 4(1)(i) 4(3)(o) and
15 4(3)(i) of this act shall be the Secretary of the
16 Department of Health and Social Affairs or her designee;
17 the allottee of funds appropriated under subsection
18 4(3)(m) of this act shall be the Vice President of the
19 Federated States of Micronesia or his designee; the
20 allottee of funds appropriated under subsections
21 4(3)(n), 4(3)(v), 4(3)(w), 4(3)(x), of this act shall be
22 the Meninkeder Lapalap of Madolenihmw. The allottee of
23 funds appropriated under subsection 4(3)(y) of this act
24 shall be the Luhkenmenlap of Kittu. The allottee of
25 funds appropriated under subsection 4(3)(t) of this act

1 shall be the Pohnpei Utility Corporation (PUC). The
2 allottee of the funds appropriated under subsections
3 5(1), 5(2) and 5(7) of this act shall be the Governor of
4 Chuuk State or his designee; EXCEPT THAT the allottee of
5 funds appropriated under subsections 5(1)(a), 5(1)(b)
6 and 5(1)(o) of this act shall be the Mayor of Weno
7 Municipal Government or his designee; the allottee of
8 funds appropriated under subsection 5(1)(i) of this act
9 shall be the Saramen Chuuk Academy School; the allottee
10 of the funds appropriated under subsection 5(3) of this
11 act shall be the Mortlocks Island Development Authority
12 (MIDA); the allottee of funds appropriated under
13 subsection 5(4) of this act shall be the Mayor of Weno
14 Municipal Government or his designee; the allottee of
15 the funds appropriated under subsection 5(5) of this act
16 shall be the Southern Namoneas Development Authority;
17 the allottee of the funds appropriated under subsection
18 5(6) of this act shall be the Faichuk Development
19 Authority. The authority of the allottee to obligate
20 funds appropriated by this act shall lapse on September
21 30, 2028."

1 Section 3. This act shall become law upon approval by the
2 President of the Federated States of Micronesia or upon its becoming
3 law without such approval.

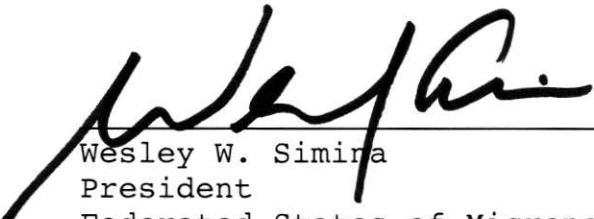
