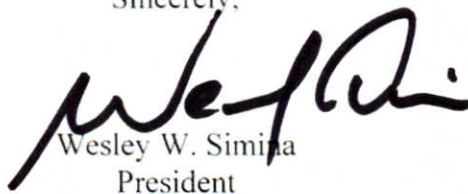
Dear Speaker Moses:

AN ACT

To further amend Public Law No. 18-70, as amended by Public Laws Nos. 18-98, 18-112, 18-122, 19-07, 19-24, 19-41, 19-52, 19-73, 19-82, 19-101, 19-114, 19-139, 20-07, 20-16, 20-36, 20-52, 20-81, 20-84, 21-15, 21-113, 21-123, 21-175, 21-192, 21-208, 21-222, 22-75, 22-130, 23-82, 23-142, 24-14, and 24-24, by amending sections 3 and 6 thereof, to change the use and extend the lapse date of certain funds previously appropriated therein, for the purpose of funding public projects and social programs for the people of Yap, Kosrae, Pohnpei, and Chuuk States, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 3 of Public Law No. 18-70, as amended by
2 Public Laws Nos. 18-98, 19-07, 19-24, 19-114, 22-75, 23-82 and
3 24-14, is hereby further amended to read as follows:

4 "Section 3. Of the sum of \$5,100,000 appropriated by this
5 act, \$750,000 is apportioned for public projects and
6 social programs in the State of Kosrae.

12 Section 2. Section 6 of Public Law No. 18-70, as amended by
13 Public Laws Nos. 18-98, 18-112, 18-122, 19-07, 19-24, 19-101, 20-07,
14 20-52, 20-84, 21-15, 21-123, 22-75, 22-130, 23-82, 23-142, 24-14,
15 and 24-24, is hereby further amended to read as follows:

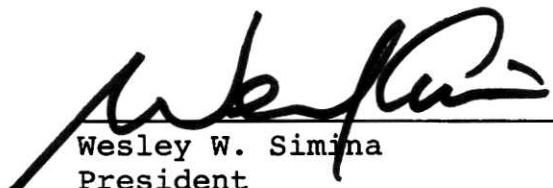
16 "Section 6. Allotment and management of funds and lapse
17 date. All funds appropriated by this act shall be
18 allotted, managed, administered and accounted for in
19 accordance with applicable laws, including, but not
20 limited to, the Financial Management Act of 1979. The
21 allottee shall be responsible for ensuring that these
22 funds, or so much thereof as may be necessary, are used
23 solely for the purpose specified in this act, and that
24 no obligations are incurred in excess of the sum
25 appropriated. The allottee of the funds appropriated

1 under section 2 of this act shall be the Governor of Yap
2 State EXCEPT THAT the funds appropriated under
3 subsection 2(i) shall be the President of COM-FSM. The
4 allottee of funds appropriated under sections 3 and 4 of
5 this act shall be the President of the Federated States
6 of Micronesia or his designee; EXCEPT THAT the funds
7 appropriated under subsections a, b, c, d, e, f, g, h,
8 i, j, k, l, m, n, o, s, t, u, v, w, x, ag, ah, aj and ap
9 of section 3 this act shall be the Mayor of Lelu Town
10 Government or his designee; the allottee of funds
11 appropriated under subsection 3(q) of this act shall be
12 the Mayor of Malem Municipal Government or his designee;
13 the allottee of funds appropriated under subsections
14 3(y), 3(aa) and 3(ao) of this act shall be the Governor
15 of Kosrae or his designee; the allottee of funds
16 appropriated under sections 3(aq) and 3(ar) of this act
17 shall be the Mayor of Malem Municipal Government or his
18 designee; the allottee of funds appropriated under
19 sections 4(3)(a), 4(3)(n), 4(3)(t) and 4(3)(ae) of this
20 act shall be the Secretary of the Department of
21 Transportation, Communications and Infrastructure or his
22 designee; the funds appropriated under subsections a, b,
23 c, d, e, f and g of section 4(1), subsections 4(3)(b),
24 (c), (d), (f), (p), r, (ac) and (ad) of this act shall
25 the Pohnpei Transportation Authority; the allottee of

1 funds appropriated under section 4(3)(u) of this act
2 shall be the Pohnpei Utility Corporation. The allottee
3 of funds appropriated under subsection 4(3)(aa) of this
4 act shall be the Meninkeder Lapalap of Madolenihmw; the
5 allottee of funds appropriated under subsection 4(4)(f)
6 shall be the Mayor of Mwokilloa Municipal Government or
7 his designee the allottee of funds appropriated under
8 subsection 4(4)(l) shall be the Mayor of Pingelap
9 Municipal Government or his designee. The allottee of
10 funds appropriated under subsections 5(1) and 5(6), of
11 this act shall be the Governor of Chuuk State or his
12 designee. The allottee of funds appropriated under
13 subsection 5(2) of this act shall be the Mortlock
14 Islands Development Authority. The allottee of funds
15 appropriated under subsection 5(3) of this act shall be
16 the Mayor of Weno Municipal Government or his designee.
17 The allottee of funds appropriated under subsection 5(4)
18 of this act shall be the Southern Namoneas Development
19 Authority. The allottee of funds appropriated under
20 subsection 5(5) of this act shall be the Faichuk
21 Development Authority. The authority of the allottee to
22 obligate funds appropriated by this act shall lapse on
23 September 30, 2028.”

Section 3. This act shall become law upon approval by the President of the Federated States of Micronesia or upon its becoming law without such approval.
