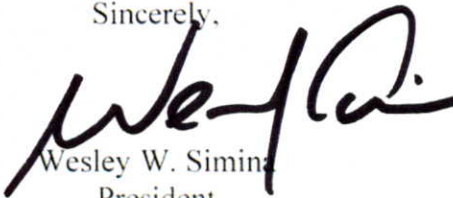
Dear Speaker Moses:

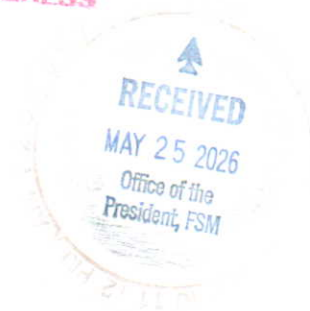

AN ACT

To further amend Public Law No. 19-89, as amended by Public Laws Nos. 19-94, 19-127, 19-151, 19-159, 20-06, 20-32, 20-136, 21-13, 21-87, 21-111, 21-132, 21-159, 21-172, 22-151, 23-93, 23-160, and 24-15, by amending section 6 thereof, to extend the lapse date of funds previously appropriated therein, for the purpose of funding public projects and social programs in each of the states, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1       Section 1. Section 6 of Public Law No. 19-89, as amended by  
2 Public Laws Nos. 19-94, 19-127, 20-06, 20-136, 21-13, 21-132, 21-  
3 159, 21-172, 22-151, 23-93, and 24-15, is hereby further amended  
4 to read as follows:

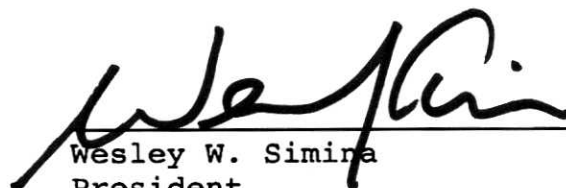
5           "Section 6. Allotment and management of funds and lapse  
6 date. All funds appropriated by this act shall be  
7 allotted, managed, administered and accounted for in  
8 accordance with applicable laws, including, but not  
9 limited to, the Financial Management Act of 1979. The  
10 allottee shall be responsible for ensuring that these  
11 funds, or so much thereof as may be necessary, are used  
12 solely for the purpose specified in this act, and that  
13 no obligations are incurred in excess of the sum  
14 appropriated. The allottee of the funds appropriated  
15 under section 2 of this act shall be the Governor of Yap  
16 State; PROVIDED THAT, the allottee of funds appropriated  
17 under subsection 2(b) of this act shall be the President

1 of the COM-FSM. The allottee of funds appropriated  
2 under sections 3 and 4 of this act shall be the  
3 President of the Federated States of Micronesia or his  
4 designee; PROVIDED THAT, the allottee of funds  
5 appropriated under subsections 3(a), 3(b), 3(c), 3(d),  
6 3(e) 3(f), 3(g), 3(h), 3(l) and 3(m) shall be the Mayor  
7 of Lelu Town Government or his designee; the allottee of  
8 funds appropriated under subsections 3(i), 3(j), 3(k),  
9 3(p) and 3(q) shall be the Mayor of Tafunsak Municipal  
10 Government; the allottee of funds appropriated under  
11 subsection 4(2)(c) shall be the Secretary of the FSM  
12 Department of Education or her designee; the allottee of  
13 funds appropriated under subsections 4(2)(a), 4(2)(b),  
14 4(2)(d), 4(2)(e), 4(2)(f), 4(3)(h), 4(4)(a), 4(4)(b),  
15 4(4)(c), 4(4)(d) and 4(4)(e) shall be the Secretary of  
16 the Department of Transportation, Communications and  
17 Infrastructure or his designee; the allottee of funds  
18 appropriated under subsections 4(3)(a) and 4(3)(b) shall  
19 be the Pohnpei Transportation Authority; the allottee of  
20 funds appropriated under subsection 4(4)(f) shall be the  
21 Pohnpei Utility Corporation. The allottee of funds  
22 appropriated under subsections 5(1) and 5(6) of this act  
23 shall be the Governor of Chuuk State or his designee.  
24 The allottee of funds appropriated under subsection 5(2)  
25 of this act shall be the Mortlock Islands Development

1 Authority. The allottee of funds appropriated under  
2 section 5(3) of this act shall be the Mayor of Weno  
3 Municipal Government or his designee. The allottee of  
4 funds appropriated under subsection 5(4) of this act  
5 shall be the Southern Namoneas Development Authority.  
6 The allottee of funds appropriated under subsection 5(5)  
7 of this act shall be the Faichuk Development Authority.  
8 The authority of the allottee to obligate funds  
9 appropriated by this act shall lapse on September 30,  
10 2028."

11 Section 2. This act shall become law upon approval by the  
12 President of the Federated States of Micronesia or upon its  
13 becoming law without such approval.
