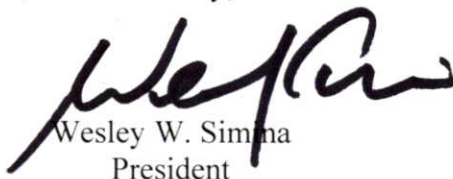
Dear Speaker Moses:

AN ACT

To further amend Public Law No. 20-95, as amended by Public Laws Nos. 20-173, 21-47, 21-72, 21-85, 21-125, 21-151, 22-143, 23-106, and 24-33, by amending section 6 thereof, to extend the lapse date of funds previously appropriated therein, to fund public projects and social programs for the people in each of the states, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 6 of Public Law No. 20-95, as amended by
2 Public Laws Nos. 21-125, 22-143, 23-106, and 24-33, is hereby
3 amended to read as follows:

4 "Section 6. Allotment and management of funds and lapse
5 date. All funds appropriated by this act shall be
6 allotted, managed, administered and accounted for in
7 accordance with applicable laws, including, but not
8 limited to, the Financial Management Act of 1979. The
9 allottee shall be responsible for ensuring that these
10 funds, or so much thereof as may be necessary, are used
11 solely for the purpose specified in this act, and that
12 no obligations are incurred in excess of the sum
13 appropriated. The allottee of the funds appropriated
14 under section 2 of this act shall be the Governor of Yap
15 State or his designee, PROVIDED THAT, the allottee of
16 funds appropriated under subsection 2(c) and 2(h) of
17 this act shall be the President of the Federated States
18 of Micronesia or his designee; and PROVIDED THAT the

1 allottee of funds appropriated under subsection 2(a) of
2 this act shall be the President of the COM-FSM or his
3 designee. The allottee of funds appropriated under
4 sections 3 and 4 of this act shall be the President of
5 the Federated States of Micronesia or his designee;
6 PROVIDED THAT, the allottee of funds appropriated under
7 subsections 3(a) to 3(l) of this act shall be the Mayor
8 of Tafunsak Municipal Government or his designee; the
9 allottee of funds appropriated under subsections 3(m) to
10 3(q) of this act shall be the Mayor of Lelu Municipal
11 Government or his designee; the allottee of funds
12 appropriated under subsections 4(1)(e), 4(2)(a),
13 4(2)(b), 4(2)(d) and 4(2)(f) of this act shall be the
14 Pohnpei Transportation Authority; the allottee of funds
15 appropriated under subsections 4(2)(c) of this act shall
16 be the President of the COM-FSM or his designee; the
17 allottee of funds appropriated under subsection 4(2)(e),
18 4(2)(g), 4(2)(h) and 4(2)(i) of this act shall be the
19 Secretary of the Department of Transportation,
20 Communications and Infrastructure or his designee; the
21 allottee of funds appropriated under subsections 4(3)(g)
22 and 4(3)(m) of this act shall be the Lukenmoanlap of
23 Kitti; the allottee of funds appropriated under
24 subsection 4(3)(f) of this act shall be the FSM National
25 Olympic Committee; the allottee of funds appropriated

1 under subsections 4(3)(h) and 4(3)(l) of this act shall
2 be the Chief Justice of Madolenihmw; the allottee of
3 funds appropriated under subsection 4(4)(c) of this act
4 shall be the Mayor of Pingelap Municipal Government or
5 his designee; the allottee of funds appropriated under
6 subsection 4(4)(d) of this act shall be the Mayor of
7 Mwokilloa Municipal Government or his designee. The
8 allottee of the funds appropriated under subsections
9 5(1) and 5(6) of this act shall be the Governor of Chuuk
10 State or his designee; the allottee of the funds
11 appropriated under subsection 5(2) of this act shall be
12 the Mortlocks Island Development Authority (MIDA); the
13 allottee of the funds appropriated under subsection 5(3)
14 of this act shall be the Mayor of Weno Municipal
15 Government or his designee; the allottee of the funds
16 appropriated under subsection 5(4) of this act shall be
17 the Southern Namoneas Development Authority; the
18 allottee of the funds appropriated under subsection 5(5)
19 of this act shall be the Faichuk Development Authority.
20 The authority of the allottee to obligate funds
21 appropriated by this act shall lapse on September 30,
22 2028."

1 Section 2. This act shall become law upon approval by the
2 President of the Federated States of Micronesia or upon its
3 becoming law without such approval.

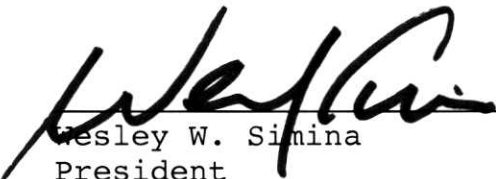
