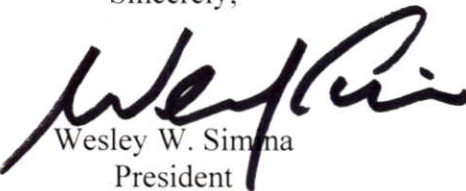
Dear Speaker Moses:

AN ACT

To further amend Public Law No. 21-80, as amended by Public Laws Nos. 21-99, 21-110, 21-143, 21-181, 21-188, 21-214, 21-242, 22-19, 22-38, 22-56, 22-99, 22-108, 22-142, 22-199, 23-17, 23-99, 23-162, and 24-03, by amending section 6 thereof, to extend the lapse date of certain funds previously appropriated therein, to fund public projects and social programs for the people of the states of Yap, Kosrae, Pohnpei, and Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 6 of Public Law No. 21-80, as amended by
2 Public Laws Nos. 21-99, 21-110, 21-143, 21-181, 22-19, 22-108,
3 23-99, and 24-03, is hereby further amended to read as follows:

4 "Section 6. Allotment and management of funds and lapse
5 date. All funds appropriated by this act shall be
6 allotted, managed, administered and accounted for in
7 accordance with applicable laws, including, but not
8 limited to, the Financial Management Act of 1979. The
9 allottee shall be responsible for ensuring that these
10 funds, or so much thereof as may be necessary, are used
11 solely for the purpose specified in this act, and that
12 no obligations are incurred in excess of the sum
13 appropriated. The allottee of the funds appropriated
14 under section 2 of this act shall be the Governor of Yap
15 State or his designee; PROVIDED THAT, the allottee of
16 funds appropriated under subsection 2(a) of this act
17 shall be the President of COM-FSM; the allottee of funds

1 appropriated under subsections 2(c) and 2(d) of this act
2 shall be the President of the Federated States of
3 Micronesia or his designee. The allottee of funds
4 appropriated under sections 3 and 4 of this act shall be
5 the President of the Federated States of Micronesia or
6 his designee; PROVIDED THAT, the allottee of funds
7 appropriated under subsection 3(1) of this act shall be
8 the Governor of Kosrae State or his designee; EXCEPT
9 THAT the allottee of funds appropriated under section
10 3(1)(k) of this act shall be the Mayor of Malem
11 Municipal Government or his designee; the allottee of
12 funds appropriated under subsection 3(2) of this act
13 shall be the Mayor of Lelu Town Government or his
14 designee; the allottee of funds appropriated under
15 subsections 4(2) and 4(3)(o) of this act shall be the
16 Secretary of the Department of Transportation,
17 Communications and Infrastructure, except that the
18 allottee funds appropriated under subsection 4(2)(f)
19 shall be the Pohnpei Port Authority (PPA); the allottee
20 of funds appropriated under subsection 4(2)(r) of this
21 act shall be the Pohnpei Transportation Authority (PTA);
22 the allottee of funds appropriated under subsections
23 4(3)(a), 4(3)(l) and 4(3)(m) of this act shall be the
24 Pohnpei Transportation Authority (PTA); the allottee of
25 funds appropriated under subsections 4(3)(b) and 4(3)(c)

1 of this act shall be the Luhkenmoanlap of Kitti; the
2 allottee of funds appropriated under subsections
3 4(3)(e), 4(3)(f), and 4(3)(g) of this act shall be the
4 Meninkeder of Madolenihmw; the allottee of funds
5 appropriated under subsections 4(3)(i) and 4(3)(j) of
6 this act shall be the Secretary of the Department of
7 Health and Social Affairs or his designee; the allottee
8 of funds appropriated under subsection 4(3)(h) of this
9 act shall be the Director of COM Land Grant Program or
10 his designee; the allottee of funds appropriated under
11 subsection 4(3)(n) of this act shall be the Vice
12 President of the Federated States of Micronesia or his
13 designee. The allottee of the funds appropriated under
14 subsections 5(1) and 5(6) of this act shall be the
15 Governor of Chuuk State or his designee; the allottee of
16 the funds appropriated under subsection 5(2) of this act
17 shall be the Mortlocks Island Development Authority
18 (MIDA); the allottee of funds appropriated under
19 subsection 5(3) of this act shall be the Mayor of Weno
20 Municipal Government or his designee; the allottee of
21 the funds appropriated under subsection 5(4) of this act
22 shall be the Southern Namoneas Development Authority;
23 the allottee of the funds appropriated under subsection
24 5(5) of this act shall be the Faichuk Development
25 Authority. The authority of the allottee to obligate

1 funds appropriated by this act shall lapse on September
2 30, 2028."

3 Section 2. This act shall become law upon approval by the
4 President of the Federated States of Micronesia or upon its
5 becoming law without such approval.
