A RESOLUTION

To approve and accept a grant in the amount of \$5,123,720 from the United Nations Children's Fund (UNICEF) for providing support to the UNICEF Pacific Country Workplan 2025-2026, including all the terms and conditions of the assistance.

1 WHEREAS, the United Nations Children's Fund issued a Grant
2 Award on July 01, 2025, to the Government of the Federated
3 States of Micronesia providing funding in the amount of
4 \$5,123,720, for the purpose of providing support to the UNICEF
5 Pacific Country Workplan 2025-2026; and

6 WHEREAS, section 210(2) of title 55 of the Code of the
7 Federated States of Micronesia (Annotated), as amended, requires
8 that for foreign financial assistance to be valid it must be
9 approved by Congress by resolution; and

10 WHEREAS, the Government of the Federated States of
11 Micronesia wishes to express its appreciation and gratitude to
12 the United Nations Children's Fund for extending this grant;
13 now, therefore,

14 BE IT RESOLVED by the Twenty-Fourth Congress of the
15 Federated States of Micronesia, Third Special Session, 2026, that
16 Congress hereby approves and accepts the \$5,123,720 grant from
17 the United Nations Children's Fund, including all the terms and
18 conditions thereof; and

1 BE IT FURTHER RESOLVED that certified copies of this
2 resolution be transmitted to the President of the Federated
3 States of Micronesia, the Secretary of the Department of
4 Justice, and the Secretary of the Department of Foreign Affairs.
