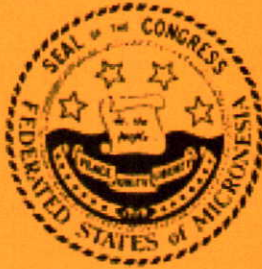

A RESOLUTION

To approve and accept a grant in the amount of \$478,510 from the United State Department of Health and Human Services, Centers for Disease Control and Prevention, for funding the FSM Public Health Emergency Preparedness Program, including all the terms and conditions of the assistance.

1 WHEREAS, the United State Department of Health and Human
2 Services, Centers for Disease Control and Prevention, issued a
3 Grant Award on June 18, 2026, to the Government of the Federated
4 States of Micronesia providing funding in the amount of \$478,510
5 for the purpose of providing support to the FSM Public Health
6 Emergency Preparedness Program; and

7 WHEREAS, section 210(2) of title 55 of the Code of the
8 Federated States of Micronesia (Annotated), as amended, require
9 that for foreign financial assistance to be valid it must be
10 approved by Congress by resolution; now, therefore,

11 BE IT FURTHER RESOLVED by the Twenty-Fourth Congress of the
12 Federated States of Micronesia, Third Special Session, 2026,
13 that Congress hereby approves and accepts the \$478,510 grant
14 from the United States Department of Health and Human Services,
15 Centers for Disease Central and Prevention; and
