CONGRESSIONAL RESOLUTION NO. 24-148

A RESOLUTION

Approving and accepting a grant from the United Nations Children's Fund, North Pacific Field Office, in the amount of \$13,000 to fund the implementation of the Federated States of Micronesia-UNICEF Child Protection Policy Workplan, including all the terms and conditions of the assistance.

1 WHEREAS, the United Nations Children's Fund, North Pacific
2 Field Office, extended to the Government of the Federated States
3 of Micronesia a grant in the amount of \$13,000 for the
4 implementation of Phase 1-Scoping Mission of the National Child
5 Protection Policy Workplan; and

6 WHEREAS, section 210(2) of title 55 of the Code of the Federated
7 States of Micronesia (Annotated), as amended, requires that for foreign
8 financial assistance to be valid it must be approved by Congress by
9 resolution; now, therefore,

10 BE IT RESOLVED by the Twenty-Fourth Congress of the Federated
11 States of Micronesia, Third Special Session, 2026, that Congress
12 hereby approves and accepts the grant in the amount of \$13,000
13 from the United Nations Children's Fund, North Pacific Field
14 Office, to fund the various health and social programs and to
15 carry out the National Child Protection Policy Workplan with the
16 United Nations Children's Fund, including all the terms and
17 conditions thereof; and

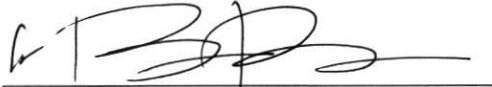
1 BE IT FURTHER RESOLVED, that certified copies of this
