A RESOLUTION

Approving and accepting a grant in the amount of \$1,236,264 from the United States Department of Health and Human Services, Centers for Disease Control and Prevention, to support and fund the FSM Immunization and Vaccines for Children Program, including all the terms and conditions of the assistance.

1 WHEREAS, on June 24, 2026, United States Department of Health
2 and Human Services, Centers for Disease Control and Prevention,
3 issued a Grant Award in the amount of \$1,236,264, to fund the FSM
4 Immunization and Vaccines for Children Program for the budget
5 period from July 01, 2026, to June 30, 2027; and

6 WHEREAS, the grant shall support the FSM Immunization and
7 Vaccines for Children Program's activities and efforts in
8 planning, developing, and maintaining a public health workforce
9 that help assure high immunization coverage level and low
10 incidence of vaccine-preventable disease, as well as improving the
11 ability to respond to public health threats; and

12 WHEREAS, section 210(2) of title 55 of the Code of the Federated
13 States of Micronesia (Annotated), as amended, requires that for foreign
14 financial assistance to be valid it must be approved by Congress by
15 resolution; now, therefore,

16 BE IT RESOLVED by the Twenty-Fourth Congress of the Federated
17 States of Micronesia, Third Special Session, 2026, that Congress
18 hereby approves and accepts the \$1,236,264 grant from United
19 States Department of Health and Human Services, Centers for

1 Disease Control and Prevention, to support and fund the FSM
2 Immunization and Vaccines for Children Program, including all the
3 terms and conditions thereof; and

4 BE IT FURTHER RESOLVED, that certified copies of this
5 resolution be transmitted to the President of the Federated States
6 of Micronesia, the Secretary of the Department of Health and
7 Social Affairs, and the Department of Finance and Administration.
