CONGRESSIONAL RESOLUTION NO. 24-150

A RESOLUTION

Approving and accepting a grant in the amount of \$166,450 from the United States Department of Health and Human Services, Administration for Children and Families, to fund and support the Personal Responsibility Education Program in the FSM, including all the terms and conditions of the assistance.

1 WHEREAS, on May 26, 2026, the United States Department of
2 Health and Human Services, Administration for Children and
3 Families, issued a Grant Award in the amount of \$166,450 to the
4 Federated States of Micronesia, Department of Health and Social
5 Affairs, to fund the Personal Responsibility Education Program in
6 the FSM; and

7 WHEREAS, the purpose of the grant is to provide funding for the
8 early intervention for teens ages 15-19, to address unhealthy, risky
9 behaviors such as early pregnancy, incomplete educational goals, and
10 negative peer pressure under the Personal Responsibility Education
11 Program; and

12 WHEREAS, section 210(2) of title 55 of the Code of the Federated
13 States of Micronesia (Annotated), as amended, requires that for foreign
14 financial assistance to be valid it must be approved by Congress by
15 resolution; now, therefore,

16 BE IT RESOLVED by the Twenty-Fourth Congress of the Federated
17 States of Micronesia, Third Special Session, 2026, that Congress
18 hereby approves and accepts the \$166,450 grant from the United
19 State Department of Health and Human Services, Administration for

1 Children and Families, to fund the Personal Responsibility
2 Education Program in the FSM, including all the terms and
3 conditions thereof; and

4 BE IT FURTHER RESOLVED, that certified copies of this
5 resolution be transmitted to the President of the Federated States
6 of Micronesia, the Secretary of the Department of Health and
7 Social Affairs, and the Secretary of the Department of Justice.
