

A BILL FOR AN ACT

To further amend Public Law No. 19-64, as amended by Public Laws Nos. 19-81, 19-97, 19-120, 19-137, 20-29, 20-86, 20-119, 21-31, 21-160, 22-18, 22-72, 22-122, 22-174, 22-200, 23-101, 24-32, and 24-74, by amending sections 1 and 2 thereof, to change the use and allottee of funds previously appropriated therein, for the purpose of funding public projects and social programs for Pohnpei State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 19-64, as amended
2 by Public Laws Nos. 19-81, 19-97, 19-120, 19-137, 20-29, 20-119,
3 22-18, 22-72, 22-200, 23-137, and 24-74, is hereby further
4 amended to read as
5 follows:

6 "Section 1. Purpose. The sum of \$3,050,000, or so much
7 thereof as may be necessary, is hereby appropriated from
8 the General Fund of the Federated States of Micronesia
9 for the fiscal year ending September 30, 2016, for the
10 purpose of funding public projects and social programs
11 in the states of Kosrae and Pohnpei. The funds
12 appropriated under this section shall be apportioned as
13 follows:

8 Section 2. Section 2 of Public Law No. 19-64, as amended
9 by Public Laws Nos. 19-81, 19-97, 20-86, 20-119, 21-31, 21-160,
10 22-18, 22-122, 23-101, 24-32, and 24-74, is hereby further
11 amended to read as follows:

12 "Section 2. Allotment and management of funds and lapse
13 date. All funds appropriated by this act shall be
14 allotted, managed, administered and accounted for in
15 accordance with applicable laws, including, but not
16 limited to, the Financial Management Act of 1979. The
17 allottee shall be responsible for ensuring that these
18 funds, or so much thereof as may be necessary, are used
19 solely for the purpose specified in this act, and that
20 no obligations are incurred in excess of the sum
21 appropriated. The allottee of the funds appropriated
22 under section 1 of this act shall be the President of
23 the Federated States of Micronesia or his designee;
24 PROVIDED THAT, the funds appropriated under subsections
25 1(d) shall be the Mayor of Lelu Town Government or his

1 designee; the allottee of funds appropriated under
2 subsection 1(f) of this act shall be the Mayor of Malem
3 Municipal Government or his designee; the allottee of
4 funds appropriated under section 1(1)(i) of this act
5 shall be the Governor of Kosrae State or his designee;
6 the allottee of funds appropriated under subsections
7 1(2)(1)(a)-(o), 1(2)(2)(a), 1(2)(2)(c), 1(2)(2)(o),
8 1(2)(4)(a)-(j) shall be the Pohnpei Transportation
9 Authority (PTA); the allottee of funds appropriated
10 under subsections 1(2)(2)(b), 1(2)(2)(d), 1(2)(2)(e),
11 1(2)(2)(f) ~~[and]~~, 1(2)(2)(n) and 2(3)(o) shall be the
12 Secretary of the Department of Transportation,
13 Communications and Infrastructure or his designee; the
14 allottee of funds appropriated under subsections
15 1(2)(2)(g), 1(2)(2)(h) and 1(2)(2)(l) shall be the
16 Pohnpei Utility Corporation; the allottee of funds
17 appropriated under subsection 1(2)(2)(m) shall be the
18 Secretary of the Department of Education or his
19 designee; the allottee of fund appropriated under
20 subsections 1(2)(4)(k)-(s) shall be the Governor of the
21 State of Pohnpei. The authority of the allottee to
22 obligate funds appropriated by this act shall lapse on
23 September 30, 2028.”

2 Section 3. This act shall become law upon approval by the
3 President of the Federated States of Micronesia or upon its
4 becoming law without such approval.
