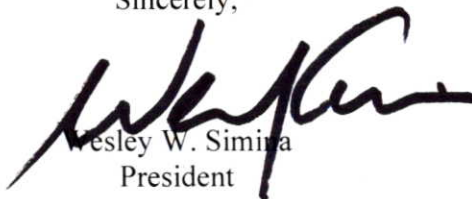
Dear Speaker Moses:

AN ACT

To further amend Public Law No. 19-60, as amended by Public Laws Nos. 19-71, 19-80, 19-103, 19-148, 19-165, 20-30, 20-128, 21-46, 21-139, 22-120, 23-100, and 24-60, by amending section 4 thereof, to change the use of certain funds previously appropriated therein, for the purpose of funding essential government functions, programs, projects, and activities in the state of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 19-60, as amended by
2 Public Laws Nos. 19-71, 19-80, and 24-60, is hereby further
3 amended to read as follows:

4 "Section 4. Of the sum of \$1,600,000 appropriated by
5 this act, \$500,000 is apportioned to fund essential
6 government functions, programs and activities in the
