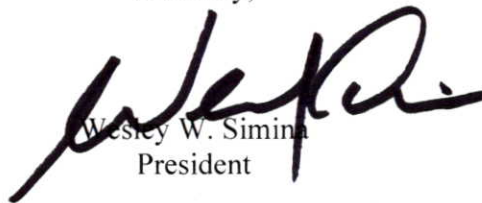

AN ACT

To further amend Public Law No. 24-56, as amended by Public Law No. 24-97, by amending section 2 thereof, to change the use of funds previously appropriated therein, to fund public projects and social programs for the people of Yap state, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 24-56, as amended by
2 Public Law No. 24-97, is hereby further amended to read as
3 follows:

4 "Section 2. Of the \$4,200,000 appropriated under this
5 act, \$600,000 shall be apportioned to fund public
6 projects and social programs for the people of Yap.
