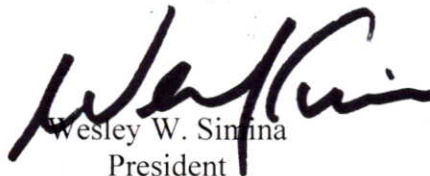
Dear Speaker Moses:

AN ACT

To further amend Public Law No. 18-117, as amended by Public Laws Nos. 18-120, 19-04, 19-08, 19-35, 19-49, 19-59, 19-76, 19-102, 20-26, 20-117, 21-27, 21-114, 21-166, 22-13, 22-71, 22-121, 22-176, 22-184, 23-83, and 24-82 by amending sections 4 and 6 thereof, to change the use and allottee of funds previously appropriated therein, for the purpose of funding public projects and social programs for the people in the state of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 18-117, as amended by
2 Public Laws Nos. 18-120, 19-04, 19-08, 19-59, 22-13, and 22-71, is
3 hereby further amended to read as follows:

4 "Section 4. Of the sum of \$2,800,000 appropriated
5 by this act, \$800,000 is apportioned for Pohnpei
6 State for public projects and social programs.

1 Section 2. Section 6 of Public Law No. 18-117, as amended
2 by Public Laws Nos. 19-04, 19-59, 19-102, 20-26, 20-117, 21-27,
3 21-166, 22-13, 22-121, 22-176, 22-184, 23-83 and 24-82, is
4 hereby further amended to read as follows:

5 "Section 6. Allotment and management of funds and lapse
6 date. All funds appropriated by this act shall be
7 allotted, managed, administered and accounted for in
8 accordance with applicable laws, including, but not
9 limited to, the Financial Management Act of 1979. The
10 allottee shall be responsible for ensuring that these
11 funds, or so much thereof as may be necessary, are used
12 solely for the purpose specified in this act, and that no
13 obligations are incurred in excess of the sum
14 appropriated. The allottee of the funds appropriated
15 under section 2 of this act shall be the Governor of Yap
16 State; PROVIDED THAT, the allottee of funds appropriated
17 under subsection 2(i) shall be the President of COM-FSM.
18 The allottee of funds appropriated under sections 3 and 4
19 of this act shall be the President of the Federated
20 States of Micronesia or his designee, PROVIDED THAT, the
21 allottee of funds appropriated under sections
22 3(a) (b) (c) (d) (e) (f) (g) (h) (i) (j) (k) (l) and (m) shall be
23 the Mayor of Lelu Town Government; the allottee of funds
24 appropriated under sections 3(n), 3(o), 3(p), 3(q), 3(r),
25 3(s), 3(t), 3(u), 3(v), 3(w), 3(x), 3(y), 3(z) 3(aa) and

1 3(ab) of this act shall be the Governor of Kosrae State
2 or his designee; the allottee of funds appropriated under
3 subsections 4(1), 4(2)(i) and 4(3)(q) of this act shall
4 be the Secretary of the Department of Transportation,
5 Communications and Infrastructure or his designee; the
6 allottee of funds appropriation under sections 4(1)(a),
7 4(1)(b), 4(1)(d), 4(3)(a) and 4(3)(f) of this act shall
8 be the Pohnpei Transportation Authority; the allottee of
9 funds appropriated under section 4(3)(h) of this act
10 shall be the Meninkeden Lapalap of Madolenimw and the
11 allottee of funds appropriated under section 4(3)(i) of
12 this act shall be the Luhkenmoanlap of Kitti; the
13 allottee of funds appropriated under subsection 4(3)(j)
14 of this act shall be the Secretary of the Department of
15 Health and Social Affairs or his designee. The allottee
16 of funds appropriated under subsections 5(1), 5(3) and
17 5(6) of section 5 of this act shall be the Governor of
18 Chuuk State or his designee. The allottee of funds
19 appropriated under subsection 5(2) of section 5 of this
20 act shall be the Mortlock Islands Development Authority.
21 The allottee of funds appropriated under subsection 5(4)
22 of section 5 of this act shall be the Southern Namoneas
23 Development Authority. The allottee of funds
24 appropriated under subsection 5(5) of section 5 of this
25 act shall be the Faichuk Development Authority. The

1 authority of the allottee to obligate funds appropriated
2 by this act shall lapse on September 30, 2028."

3 Section 3. This act shall become law upon approval by the
4 President of the Federated States of Micronesia or upon its becoming
5 law without such approval.
